**ORDER**

**Sub.:** Promotion and postings of STS officers of Indian Postal Service (IPoS), Group 'A' on ad hoc basis to Junior Administrative Grade (JAG) of the Service and transfer/posting of a JAG officer of IPoS, Group 'A'.
