This is in continuation with this Directorate letter of even number dated 10.04.2018 and 26.04.2018, where-under result of LDCE PS Group 'B' for the years 2012-13 to 2016-17, held on 18th December, 2016, was declared.

2. The result of total 17 provisionally admitted candidates [13 from IP Line & 4 from General Line] who had found their place in the zone of selection was withheld due to non-finalization of their provisional candidature by the concerned Circle.
3. Now, the candidature of 9 provisionally admitted candidates [7 IP line + 2 General line] out of total 17 candidates has been regularized by their respective Circles. The Competent Authority has, therefore, decided to release the result of these 9 candidates, and the result is being hereby declared as Annexed.
4. The marks/result of other candidates, who also had been admitted provisionally to the exam due to various reasons and whose candidature has been cleared by the concerned Circle, but have not come in the zone of selection, will be released separately.
5. SPG-II Section of the Directorate is requested to arrange the position of the selected candidates in the order of merit taking into account this Section's letter of even number dated 10.04.2018 & 26.04.2018.
6. Circles are requested to regularize the candidature of all other provisionally admitted candidates, so that their marks/result could be declared without any further delay.
7. The Heads of Circles are requested to take further necessary action for circulation of the contents of this communication to all concerned.
