R/Sir,

With due respect, I have to inform that the below noted resolution has been passed unanimously in the XII<sup>th</sup> All India conference of this Association, held on 7<sup>th</sup> & 8<sup>th</sup> September 2019 at Gandhi Nagar (Gujrat) regarding amendment in the name of the Association -

"The name of the Association, henceforth, shall be "All India Postal SC/ST Employees welfare Association" in place of All India P&T SC/ST Employees welfare Association".

It was felt necessary by all the members because the Central Govt. had abolished the Telegraphs Deptt. and separate SC/ST Associations were formed in Deptt. of Telecom including MTNL & BSNL. Hence there was no logic to carry on the word "T" with the name of this Association having activities only for SC/ST Employees of Postal Department.

You are, therefore, requested to kindly issue necessary directions to all concerned in Directorate and subordinate offices to note in all records and further correspondence.
