






2. In case the officers wish to choose the date for fixation of pay under FR-22(D)(a)(1), they can do so within one month from the date of issue of this order.

The office where the officers are posted on their regular promotion to JAG should issue their promotion orders only after verifying that no disciplinary proceedings are pending or contemplated against them. In case of pendency of such proceedings, the matter may be reported to this office immediately.
