विषय/Sub: Compassionate Engagement against the posts of Gramin Dak Sevaks -Reg

The Committee on Compassionate Engagement (CCE) met on 26.07.2022 and the details of the cases recommended by the Competent Authority, are furnished in **Annexure-I**.

2. I am directed to inform that the candidate(s) whose cases recommended for engagement as GDS on compassionate grounds and approved by the Competent Authority, should be engaged provisionally within 10 (Ten) days from the date of receipt of this letter, duly observing all the pre-engagement formalities. The orders thus issued should contain a clause to the effect that their continuance in the post will be subject to satisfactory result of police verification. The date on which the provisional engagement orders are issued in respect of each candidate / post should be reported to Circle Office by **27.10.2022**.

3. The instructions regarding production of certificate of 60 days course of computer knowledge should be ensured from all candidates approved for compassionate engagement before engaging them.


4. The approved candidates should be provided engagement against the post for which his / her candidature was approved. It is the responsibility of the engaging authority to ensure genuineness of educational qualification of the candidate(s) considered for compassionate engagement. And also to intimate the candidate(s) approved in the light of Directorate instructions vide letter No.17-01/2017-GDS (Vol-I) dated 09.02.2022 to acquire the education qualification and engage them as provisionally as per the extant rules.

5. All case files listed in Annexure-I and Annexure-II are returned herewith for taking further necessary action.

6. Speaking order of rejected case mentioned in Annexure-II is enclosed for arranging delivery of the same under proper acquittance and copy of the acquittance may be sent to Circle Office for record. Kindly acknowledge the receipt of this letter along with case files by return post.


