In case, if it is found subsequently that any of the promoted / selected candidate was not eligible for the examination/ selection under the existing rules/ instructions on the subject or for any other reasons or in case any mistake is found with regard to declaration of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject.



6. The result of all successful candidates is subject to fulfillment of eligibility criteria to be decided by the concerned Divisional/ Unit Head and vigilance status of the candidates. The official/ candidate against whom vigilance or disciplinary case is pending/ those undergoing punishment should not be promoted and such cases should be referred back to this office as per directions of directorate's letter no. X-7/6/2022-SPN-II dated 17.05.2023, 22.09.2023 & 04.03.2024.

7. Appointment of candidates for promotion and seniority of selected candidates is subject to outcome of WP No. 2422/2021 pending before Hon'ble High Court, Jaipur.


8. All the Divisional Heads/ Appointment Authorities are requested to cause issuance of promotion/ appointment orders by **04.10.2024**. The appointment authorities are also requested to carry out all the required pre-appointment formalities as provide in relevant rules and instructions issued from time to time.

9. Divisional / Unit Heads are requested that no selected willing MTS will be relieved to join till further communication from this office. Divisions will obtain the willingness/unwillingness from the selected candidates. All the selected willing MTS will be relieved on a particular date fixed by this office for which separate instructions will be issued.

10. Divisional Heads concerned are directed to submit the unwillingness/refusal (unconditional) of the candidate by 04.10.2024 positively. If any Division/Unit especially in which the candidate is presently working is failed to submit the refusal within stipulated time to Circle Office, they will be held responsible for that.

11. Request for revised allotment of any candidate will not be entertained.
