#### 2. General Condition: -

- (a) The promotion will be effective from the date of assumption of charge of the post of Inspector Posts.
- (b) Official(s) shall immediately be appointed to the post on promotion and shall be deputed for Induction training as and when slots become available in Training Centers.
- (c) Officials shall be on probation for a period of two years
- (d) Request for re-allotment to any other Circle / Unit shall not be entertained under any circumstances. Therefore, Circle(s) should refrain from making such recommendations.
- (e) Official shall be relieved within 15 days of issue of this order subject to condition mentioned in Para 3 below. Relieving Circle shall not await posting order from allotted Circle and shall relieve the official and direct them to report in Circle Office of allotted Circle.
- (f) In case official is not willing to join promoted post, declination letter shall be obtained by parent Circle and forwarded to Directorate latest by 18.01.2025.
- (g) It is the officer's responsibility to send a copy of charge report on assumption of charge of the post of Inspector Posts through eMail at adspn.dte@indiapost.gov.in
- 3. Circle shall ensure vigilance status of the official in terms of Directorate letter no. X-7/6/2022-SPN-II dated 17.05.2023 as amended from time to time, before relieving him/her for promotion to the cadre of Inspector Posts. In case any official falls under any of the category which attracts provision of 'deemed sealed cover', such officials should not be relieved and the matter be immediately reported to Directorate.
- 4. Before relieving an official on promotion, it shall be ensured compliance of all instructions contained in Directorate letter no. A-34020/01/2024-DE dated 17<sup>th</sup> December 2024. It may also be ensured that candidates selected as PwBD, were in possession of valid PwBD Certificate issued by Competent Authority. Official(s) shall be eligible for fixation of pay on promotion under prevailing instructions on the subject.
