
3. The result is prepared based on clarification given by Directorate vide letter No. 03-03/2019/SPN-I dated 19.06.2019 and Notification of the aforesaid examination. As per aforesaid clarification and Notification of the examination, candidates who exercised limited number of preferences and could not be allotted to prefer Division / Unit due to non-availability of vacancies are not considered for other Division / Units.

4. Further, it is observed that after declaration of result the joining formalities take so much time to complete due to which further process of filling up the vacancies is badly delayed. Hence, Regions / Divisions/Units are requested to complete all joining formalities within following time line: -

- i. Issue the offer of appointment letter by - 28/1/2025
- ii Inform the unfilled vacancies due to non-joining of candidates to Region – 31/1/25
- iii Consolidated report by Region to CO: - 31/01/2025
