- 3. The selection of candidates has been made as per as per procedure of selection of candidate based on single examination for the post of MTS/Postman / Mail Guard vide Directorate's letter no. 17-08/2018-SPN-I dated 18.10.2023 followed by letter dated 31.10.2023. The merit list has been prepared on the basis of marks secured in Paper-I only.
- 4. In case, candidates have obtained same marks in Paper-I, their inter-se merit has been decided as per instructions in Postal Directorate letter no.04-08/2019-SPN-I dated 11.12.2020.
- 5. The concerned controlling authorities are requested to issue posting order(s) to the candidates immediately as per their allotment above and the concerned appointing authorities are requested to issue promotion order/offer of appointment to the candidates immediately and not later than 10/02/2025. All concerned authorities must ensure that candidates selected are relieved immediately on issue of posting orders to enable them to join new place of posting. Instructions shall also be issued to candidate(s) to either accept or refuse the offer of appointment in writing. If a candidate does not give his/her acceptance or refusal within a period of 01(one)week it shall be deemed to have been refused and accordingly supplementary result will be declared, and post will be offered to next eligible candidate. Divisional Heads will send the final joining status of the candidates latest by 19/02/2025 (Wednesday) to this office.
- 6. In case, at any time it is found that any of the selected candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject or for any reasons or in any case any mistake is found regard to announcement of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion/appointment letter to be issued by the Divisions/units.
- 7. The selected candidates should note that the selection to the post of MTS is provisional subject to satisfactory verification of the details such as education qualification, case, length of service, physical disability and any other eligibility condition as per notification. If at any stage, it is noticed that the selected candidates(s) are not eligible to take the examination, under the rules or instructions on the subject or if the result of the candidate is found incorrect for any other reasons, his /her name will be deleted from the selection list.
- 8. Further, in respect of selected reserved category SC/ST/OBC(noncreamy)/EWS/PwBD candidates, the appointing authority is required to obtain and verify the category certificate in the format prescribed by Govt. of India.
- 9. Appointing authorities are requested to issue formal orders of appointment as per para 5 above and before giving appointment to the selected candidates, it may be ensured that the candidates fulfil all required conditions of relevant Recruitment Rules.



- 10. The information related to Name of candidate, Roll Number, category etc. has been shown on basis of information furnished by the concerned Divisions/units and the application forms of the candidates. The concerned Divisions/units are requested to recheck the particulars of the successful candidate such as Name, Roll Number, Category etc. before issuing the offer of appointment. If any discrepancy is noticed the same shall be corrected and matter to be reported to Circle Office.
- 11. Before appointment, it should be ensured that, no disciplinary / vigilance case is pending or punishment is current against the selected candidate. The candidate against whom any vigilance or disciplinary case is pending or those undergoing punishment should not be promoted/appointed. The particular of such candidate shall be reported to Circle Office with full details immediately.
- 12. In case, at any time, it is detected that the candidate so selected had applied and appeared in the examination with false declaration or data, his/her selection will be cancelled without notice.
