Subject: Limited Departmental Competitive Examination for promotion to the cadre of Inspector Posts (IP) for the vacancy year 2024 – declaration of results of Sri Regichettu Ravi Kumar - sealed cover case - regarding.

Sir,

I am directed to refer to the subject mentioned above and DoP letter No. A-34013/02/2024-DE dated 26.12.2024 whereby the result of the LDCE IP, held on 21st & 22nd September, 2024 was declared.

2. The result of 96 candidates were kept in Sealed cover as Annexure-B of letter dated 26.12.2024. The name of Sri Regichettu Ravi Kumar was also included at serial no. 1 in the said annexure, observing para no. 3(i)(b) of letter No. X-7/6/2022-SPN-II dated 17.05.2023, recommendation of AP Circle and the vigilance report wherein it was mentioned that Charge Sheet under Rule-16 of CCS (CCA) Rules 1965 issued vide SPOs, Proddatur Division Memo No. SB/1-2/CBS Misc-XV dated 08.09.2024 was pending.

3. The matter has been examined. Andhra Pradesh Circle vide letter dated 20.01.2025 and 04.03.2025 informed that the proceedings in Rule-16 case have been finalized. The official has been awarded with punishment of 'CENSURE' vide memo No. SB/1-2/CBS Misc/Rule-16 dated 11.10.2024. It is observed that for submitting the vigilance status report of all the candidates appeared in LDCE-IP 2025 to Directorate, RO Kurnool called for the report from Divisions/unit on 01.10.2024 and result was announced on 26.12.2024. Meanwhile, disciplinary proceedings under Rule-16 against the candidate were finalized on 11.10.2024 but latest status of the candidate was not submitted immediately by Proddatur Division.

4. Since, the disciplinary proceedings against Sri Regichettu Ravi Kumar have already been decided on 11.10.2024 with a punishment of 'CENSURE' before the date of declaration of the result i.e. 26.12.2024, therefore, his case is considered as per para 4 (a) of DoP letter No. X-7/6/2022-SPN-II dated 17.05.2023 and the Competent Authority, has accorded approval for declaring the results/marks of Sri Regichettu Ravi Kumar. The result of Sri Regichettu Ravi Kumar is declared as **Annexure-I**. The details thereof are as under:


