বিঘ্য/Sub: 'Circle Relaxation Committee' meeting held on 18.02.2025 for the vacancy year 2023 in c/w appointment of dependent of deceased Departmental employees on compassionate grounds.

\*\*\*

The Departmental Circle Relaxation Committee constituted for the purpose of considering the compassionate appointment cases for the vacancy year 2023 has met on 18.02.2025 at Andhra Pradesh Circle Office. The CRC has considered a total number of 56 cases (including 29 cases recommended by previous CRC for placing before next CRC) for compassionate appointment received from the family members of the deceased/missing departmental officials for appointment in Group-C cadre under relaxation of recruitment rules against 5% number of vacancies under Direct Recruitment Quota for the year 2023.

- 2. As per Directorate instructions on development of Online CRC module and launch of Web Portal, all the applications received from 05.04.2023 to 30.06.2024 are to be considered by CRC for the vacancy year 2023 in the Online CRC Portal. Accordingly the CRC which met on 18.02.2025 has examined the online data of each case in Online CRC web portal and processed the recommendations through web portal and issued the Minutes.
- 3. The Committee has limited its recommendations for appointment on compassionate grounds in deserving cases to the extent of 17 vacancies available under 5% of vacancies under DR Quota for 2023.

The Circle Relaxation Committee has considered and recommended the cases for Compassionate Appointment in the cadre of Group C as indicated against each case taking into consideration of the allocation of points to the applicants based on various attributes indicated in the Directorate letters No. 17-1/2022-SPG-II dated 23.03.2022 and 24.03.2022.

- 5. The Committee did not recommend the cases which did not merit selection in the comparative study of relative merit points against 5% of DR vacancies available for the purpose in accordance with the instructions/guidelines issued by DoPT/ Directorate from time to time and the list is enclosed as Annexure II. The remaining cases which were already placed before previous CRCs and placed before the present CRC for the third time and did not merit selection in the comparative study of relative merit points against 5% of DR vacancies available for the purpose and cases on reexamination not eligible / not found in indigent circumstances are rejected and the list of such rejected cases is enclosed as Annexure III.
- 4. Action may please be taken to appoint the selected candidates mentioned in Annexure-I after observing all usual formalities. It is the responsibility of Divisional Head/Appointing Authority to verify the genuineness of the certificates like Education/Community/ Date of Birth etc. as per rules on the subject. It will also be ensured that the appointment orders to the recommended applicants are issued in stipulated time with instructions.
