Subject: Limited Departmental Competitive Examination for promotion to the cadre of PS Group 'B' held on 29.11.2020 - declaration of result/marks of Sri Koneti Amarnath whose result was kept in sealed cover/deemed sealed cover-regarding

Sir,

This is in continuation of Directorate letter of even number dated 01.06.2022 vide which the results of the above LDCE for the vacancy years 2017-18, 2018, 2019 and 2020, held on 29th November 2020, were declared.


2. The name of Sri Koneti Amarnath (Roll No. 01010066) was placed at Serial No. 2 of Annexure - C (sealed cover candidates) of letter dated 01.06.2022, keeping in view the vigilance report provided by Andhra Pradesh Circle vide letter No. RE/APCO/3-13/2020 dated 21.04.2022 wherein it was mentioned that criminal case against the official lodged vide CC No. 12/2018 was pending.

3. The said criminal case has now been settled and issues amicably got compromised before LOK ADALAT BENCH, CUDDAPAH on 08.03.2025. The Court declared accused Sri Koneti Amarnath acquitted 'under section 320(8)Cr.PC for the offense punishable U/s 498(A), 506 IPC. The OA No. 159/2023 filed by Sri Koneti Amarnath before Hon'ble CAT, Hyderabad Bench, has also been dismissed on 03.02.2025 as withdrawn.

As such, there are no Disciplinary /Vigilance cases/criminal cases pending against the Sri Koneti Amarnath.

4. Keeping in view the above latest vigilance report, recommendations of CPMG, A.P. Circle and the instructions/guidelines stipulated in letter No. X-7/6/2022-SPN-II dated 12.04.2022 & 10.11.2022 and OM No. 9-36/2021-SPG-II dated 12.04.2022, the Competent Authority has accorded approval for declaration of the result/marks of Sri Koneti Amarnath.

The said candidate (IP Line) is coming in the zone of selection for the vacancy year 2018 and thus, his result/marks is being hereby declared as successful and appended as Annexure. The candidate may be informed accordingly.


