ORDER**Subject: Inter Circle transfer in the cadre of Assistant Superintendent of Posts -reg.**

This is regarding the inter-Circle transfer orders issued vide order No. X-06/3/2024-SPN-II dated 04.04.2025 in the cadre of Assistant Superintendent of Posts (ASPs)

2. It is observed that despite clear instructions contained in Para 3 of the above-mentioned transfer order stipulating that officers shall be relieved within 30 days. Some Circles/Units have not complied with the order and several officers are yet to be relieved. The list of such officers is enclosed as **Annexure-I**.

3. In view of the above, the following instructions are issued for strict compliance:

a. Officer(s) who have not yet been relieved shall stand "deemed relieved" from their present Circle/Unit and are directed to report to allotted Circle/Unit without waiting for formal relieving order from their present Circle/Unit within 10 days from the date of issue of this letter.

b. The only exception to the above shall be in respect of officers who fall under the purview of conditions mentioned in Para 2 of DoPT's O.M. No. 22011/4/91-Estt. (A) dated 14.09.1992.

c. It shall be the responsibility of the respective Circle/Unit and the officer concerned to ensure that no salary is drawn in the parent Circle/Unit beyond the deemed relieving date.

d. Details of officers who fail to join their allotted Circles/Units after the stipulated date shall be furnished by the concerned Circle/Unit without any delay.

4. A copy of relieving/ joining charge report may also be furnished to the email Id adspn.dte@indiapost.gov.in for information and record.
