I am directed to refer to the subject mentioned above, letter under reference and DoP letter No. A-34013/01/2022-DE dated 20.12.2022 whereby the result of the LDCE IP, held on 25th & 26th June, 2022, was declared.

2. The result of 220 candidates were kept in Sealed cover as Annexure-B of letter dated 20.12.2022. The name of Shri Rohit Kumar Ahirwar was also included at serial no. 89 in the said annexure, observing para no. 3(i)(c) of letter No. X-7/6/2022-SPN-II dated 12.04.2022, recommendation of MP Circle and the vigilance report wherein it was mentioned that "a criminal case was pending against the official before the court."

Afterwards, MP Circle vide letter dated 01.05.2025 has informed that he is exonerated from the said criminal case by the Court and also, no disciplinary proceedings are pending against him.

- 4. Accordingly, the Competent Authority, after careful consideration of the case, has accorded approval for declaring the results/marks of Shri Rohit Kumar Ahirwar. The result of Shri Rohit Kumar Ahirwar is therefore declared as per **Annexure**. The details thereof are as under:
