I am directed to intimate that Limited Departmental Competitive Examination (Common Examination-2025) among MTS for promotion to Postman/Mail Guard for the vacancies of the year 2025 (01.01.2025 to 31.12.2025) was held on 31.08.2025, followed by DEST conducted on 21.09.2025 as per the notification issued vide this office letter No. RE/3-7/LDCE/2025 dated 16.07.2025 in accordance with the Directorate instructions contained in Letter No. 17-08/2018-SPN-I dated 05.04.2022.

2. The Provisional and Final Answer Keys (of Series A, B, C & D) of Paper-I, Paper-II and Paper-III of the above mentioned examination held in Andhra Pradesh Circle were already published in the Departmental website - www.indiapost.gov.in.

3. In pursuance of Directorate instructions contained in Letter No. 17-08/2018-SPN-I dated 05.04.2022, the candidates who qualified in Paper-I, Paper-II, Paper-III and Paper-IV (DEST) separately shall be considered for final selection and the Merit List will be prepared only on the basis of total (combined) marks secured in Paper-I and Paper-II, since Paper-III and Paper-IV (DEST) are qualifying in nature. As per the Department of Posts Postman and Mail Guard Recruitment Rules, 2018, amended vide Gazette Notification dated 30.08.2023 and Postal Directorate letter No. 17-08/2018-SPN-I dated 18.10.2023 (Procedure for selection of candidate based on single examination for posts of Postman/Mail Guard and MTS), the result has been compiled taking the scores of Paper-I and Paper-II (combined) for Circle Merit.

4. Further, the orders/guidelines relating to Reservation in promotion to Persons with Benchmark Disabilities vide DoPT OM No. 36012/1/2020-Estt. (Res.-II) dated 17.05.2022 & Directorate letter No. X-20/17/2024-SPN-II dated 13.08.2024 along with DoPT OM No. 36035/02/2017-Estt (Res) dated 27.09.2022, and other extant rules/guidelines issued by Directorate from time to time have been ensured.

9. The Divisional/Unit Heads, before giving appointment to the selected candidates should ensure that the selected candidates fulfill all required eligibility conditions of relevant Recruitment Rules of Postman/Mail Guard cadre. Also, the Divisional/Unit Heads are advised to re-check all pre-requisite eligibility conditions prescribed for candidates, with reference to their recommendations made while forwarding the application forms.
10. Before appointment, it should be ensured that, no disciplinary/vigilance case is pending or contemplated or punishment is in force against the successful/selected/allotted candidates. If, any such case exists, the same should be referred to this office immediately before issue of any further orders.
11. The information relating to name(s) of the candidate(s), Roll Number(s) and Category(ies) etc., have been shown on the basis of information furnished by the Regions/Divisions/Units. In case of any errors noticed in the details of candidate(s), the same may be intimated to this office for necessary action.
13. The names of the candidates have been arranged in the order of Circle Merit in the Examination. The *inter-se* rank/merit of candidates who have secured equal marks has been decided as per Directorate's instructions/guidelines in Letter No. 04-08/2019-SPN-I dated 11.12.2020.
14. The candidates of reserved category i.e., SC/ST who are shown as qualified on merit and selected against UR vacancies should be adjusted against UR vacancies in the Roster.
15. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case of any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates. Further, in case at any time, it is detected that the selected candidate had applied and appeared the examination with false information/declaration or data, his/her selection will be cancelled without any notice.
16. It may be ensured that no provisionally permitted candidate is given appointment without regularization of his/her candidature. The Divisions/Regions are directed to verify the current status of the candidature of the qualified candidates before issuing the offer of appointment to the promoted post/cadre.
17. The Division/Unit Heads should ensure timely issue of offer of appointment letters to the successful candidates so that the selected candidates/officials join in their respective offices of posting at the earliest as per extant rules.



18. The successful candidates may be directed to accept and join in the place(s) of posting on promotion or to decline the promotion (Format enclosed) within 7 (seven) days i.e. **by 06.10.2025**. The Divisional Heads are requested to issue promotion/appointment orders to the successful candidates, immediately and indicating clearly that if the official did not join the promotional post within seven (07) days, it will be treated as deemed to have been declined/refused. Official on leave may be allowed to join even after seven days, if he/she communicate acceptance of the promotion in writing and in that case the official will be allowed to join in the post after expiry of approved leave period. *Controlling Officers are advised to contact such successful candidates who are on leave for obtaining their consent to join promotional post in writing. Similarly, candidates who do not wish to join promotional post may be encouraged to communicate the same in writing.*

19. The Divisions / Units may be directed to ensure completion of all the processes in this regard and report compliance to Circle Office **by 07.10.2025**. The guidelines issued vide Directorate letter No.W-04/2/2020-SPN-I-Part (1) dated 19.10.2020. may be taken into consideration while issuing appointment order.


