
Sub: Employment on compassionate ground case to the all Group 'C' cadres – Recommendation of the Circle Relaxation committee held on 24.06.2025 & 22.07.2025 for the vacancy year 2022 regarding.

The Circle Relaxation Committee met on 24.06.2025 & 22.07.2025 to consider the requests of dependents of deceased Departmental officials for appointment on compassionate grounds in relaxation of normal Recruitment Rules for Postal Assistants/Sorting Assistants, Postman/Mail Guard and Multi-Tasking Staff posts for the vacancy year 2022.

- 2. The Committee considered a total of 145 eligible cases for the vacancy year 2022 taking into the consideration the assigned points to the applicants calculated through compassionate appointment online portal.
- 3. The Committee examined all the cases keeping in view the guidelines governing the scheme of compassionate appointment. The assessment of indigence of the dependents of the deceased Government Servants is based on the revised Relative Merit Point System issued by Directorate vide letter No.17-1 /2021-SPG-II dated 23.03.2022 and Standard Operating Procedure (SOP) issued by Directorate vide letter no. 17-1/2021-SPG-II dated 24.03.2022. Instructions contained in Directorate's letter nos. 17-1/2022-SPG-II dated 20.07.2023 and 24-44/2022-SPG-II dated 10.11.2023 have also been followed. The calculation of degree of indigence of each applicant in comparison to other cases received for consideration is done by taking into account all the relevant factors and various attributes.
- 4. The details of Direct Recruitment quota vacancies in PA/SA, PM/MG and MTS Cadres for appointment on compassionate grounds are enclosed as <u>Annexure-I</u>.
- 5. Selection to posts has been made according to merit points secured by the candidates, subject to fulfilment of other eligibility conditions.


- 6. In accordance with the approval issued by Directorate vide letter no. 24-09/2025-SPG-II dated: 17.09.2025 and approval of the Competent Authority and recommendations by the CRC, following cases for compassionate appointment have been recommended / rejected / referred to Next CRC.
  - a. Ninety-Two (92) eligible candidates who secured highest points have been "RECOMMENDED AND APPROVED" for appointment on compassionate grounds. The Competent Authority recommended to offer Postal Assistants/Sorting Assistants, Postman/Mail Guard, Multi-Tasking Staff and Multi-Tasking Staff Trainee posts to the candidates who came up in the selection zone depending upon the eligibility conditions as per the prevalent Recruitment Rules and merit points secured to the extent of vacancies reserved for compassionate appointment quota. The details of the approved cases and the allotment to the respective Divisions/Units, where the vacancies were earmarked for compassionate appointment are enclosed as <u>Annexure-II</u>.
  - b. In view of the allotment of approved candidates under compassionate grounds, following instructions are issued.
    - (i) In respect of Postal Assistant/Sorting Assistant, Postman/Mail Guard, MTS and MTS Trainee cadre allotment should be adjusted against the vacancies already reserved in Direct Recruitment quota for the vacancy year 2022.
    - (ii) The Regional Heads/Unit Heads are requested to issue suitable instructions to the concerned Divisional/Unit Heads concerned.
  - c. Twenty Seven (27) cases have been "RECOMMENDED TO BE CONSIDERED BY NEXT CRC" due to paucity of vacancies. The details of the cases are enclosed in **Annexure-III**.
  - d. Twenty Six (26) cases have been "REJECTED" due to paucity of vacancies and put up for third time and as per decision of Directorate. The details of the cases are enclosed in <u>Annexure-IV</u>.
- 7. The Postal Directorate vide letter no. 24-2/88-SPB-I dated 18.11.1991 and no. 37-4/2013-SPB-I/C dated 12.06.2013 informs that "once the candidate has accepted an appointment to a particular post on compassionate grounds, the set of circumstances which led to his initial appointment should be deemed to have ceased to exist and thereafter the person who has accepted compassionate appointment in a particular post should strive in his career like his colleagues for further advancement and claims for appointment to higher post on consideration of compassion should invariably be rejected".
  - (i) The applicant who has the higher qualifications but offered with lower posts like Postman/Mail Guard / Multi-Tasking Staff posts due to paucity of vacancies in Postal Assistant/Sorting Assistant cadre may be informed that claims for appointment to higher post on consideration of compassion will not be



- considered. A declaration to this effect may be obtained & kept on record & a copy of declaration should be sent to Circle office.
- (ii) The allotment of applicants has been made as per the preference submitted by them as far as possible. Hence, no requests for change of posting / divisions will be entertained. While issuing posting orders, efforts should be made by the concerned Division / Unit to accommodate the selected applicant as per the choice.
- 8. The following clause/conditions may invariably be included in the provisional appointment order to be issued to the candidates selected for appointment on compassionate grounds and a declaration /undertaking should be obtained and kept on service records / service book.
  - (i) That if any of the fact mentioned are found to be incorrect or false at a future date, his/her services are liable to be terminated.
  - (ii) That he/she shall maintain properly the other family members who were dependents on Government servant and in case it is proved at any time that the said family members are being neglected or not being properly maintained by him/her, his/her appointment is liable to be terminated.
- 9. If the selected candidate is in receipt of family pension, the office of payment of family pension must be informed suitably.

- (i) As per Recruitment Rules of Postman Cadre, 2018 and subsequently amended time to time, a candidate should be 12th/PUC pass from a recognized Board, should have studied Local Language i.e., Gujarati upto 10th /SSLC standard, possess knowledge of working on computer and possess a valid Driving License of two wheeler or light motor vehicle. Therefore, as per Postman/ Mail guard Recruitment (Amendments) Rules, 2020, a candidate who has been selected for the post of Postman/Mail Guard should possess computer knowledge and also should acquire Driving License to drive two wheeler within a period of two years from the date of candidate appointment.
- (ii) As per Recruitment: Rules of Mail Guard Cadre, 2018 and subsequently amended time to time, a candidate should be 12th /PUC pass from a recognized Board, studied Local language i.e. Gujarati upto 10th /SSLC standard and possess knowledge of working on computer.
- (iii) In respect of MTS Cadre, latest Recruitment Rules, 2018 and subsequently amended time to time, may be kept in view while issuing appointment orders.
- (iv) In respect of MTS Trainee an applicant has to acquire the minimum educational qualifications within a period of 5 years from the date of his appointment as MTS Trainee failing which his services would liable to be terminated as notified in view of DoP&T's No. 14014/02/2012-Estt. (D) dated 30.05.2013 & Directorate letter no. 24-73/2020-SPG-II dated 20.01.2021. The




concerned division/unit is requested to mention the abovesaid service condition in the appointment order to the applicant selected for the MTS Trainee cadre.

11. As per point no. 31 of FAQs issued by DoP&T vide OM no. 14014/02/2012-Estt.(D) dated: 30.05.2013, "A person selected for appointment on compassionate grounds should be adjusted in the recruitment roster against the appropriate category viz. SC/ST/OBC/EWS/General depending upon the category to which he belongs". Hence, the Divisional / Unit Head should obtain the respective caste certificate from the approved applicants, get the caste certificate verified and accordingly adjust the community of the applicant in the recruitment roster.

12.

- (i) Following instructions issued by DoP&T should be followed while issuing provisional appointment order to the selected candidates:
  - a. As per para no. 3 of DoPT OM No. 18011 /Z(s)/2016-Estt.(B)(i) dated 29.06.2016, it is stated that, "It has been decided that now the verification of character & antecedents will be carried out, but the issue of appointment letters need not be withheld pending such verification. The appointing authorities will issue provisional appointment letters after obtaining the attestation form and self-declaration from the candidate. The candidate along with the details of attestation form will also submit the self-declaration certifying that all facts and details given in the form are correct."
  - b. As per para no. 4 of above DoPT OM it has further been stated that, "in the provisional appointment letter, it will be clearly mentioned that in case character & antecedents of the candidate is found not verified or any false information is given by the candidate in his/her self-declaration, the provisional appointment letter will be cancelled henceforth and other criminal & legal action will also be taken, as a consequence".
  - c. Similar instructions have been issued for verification of SC/ST caste certificates in DoPT OM dated 14.03.2016 wherein under para no. 2 it is stated that, "............ has reiterated the instructions on providing provisional appointment to such reserved category candidates who are unable to obtain an appropriate caste certificate in time".
- (ii) Apropos to the above DoPT instructions, as the appointment on compassionate grounds is also through "Direct Recruitment"; these instructions apply for issue of immediate provisional appointment orders to the applicants selected through compassionate grounds.
- (iii) The applicants selected through compassionate appointment should be requested to submit all the relevant documents / educational qualification certificates / caste certificates / medical fitness form / character and antecedent



forms etc., as part of pre-appointment formalities and on satisfaction that all the documents have been submitted, the concerned Division / Region / Unit can issue "Provisional Appointment" order to such applicants with the above mentioned DoPT clauses and thereafter carry out the genuineness of the documents submitted by the applicants from the concerned authorities. This will avoid delay in joining of the applicants in the selected post / cadre.

- 13. If any applicant is found ineligible, he/she should not be appointed, but the matter should be reported to this office immediately.
- 14. The Postal Directorate vide letter no. 17-5/2020-SPG-II dated 22.03.2021 has directed to conduct typing test for the applicants below the age of 45 years who have been appointed as Postman/Mail Guard / PA/SA cadres on compassionate grounds. Further, clarification on typing test to candidates appointed on compassionate grounds issued vide Directorate letter no. SG-17/22/2024-SPG-II-DOP dated 12.12.2024 may also be considered. The concerned Regional Heads are requested to conduct the Typing Test as per the instructions contained in Directorate letter no. ibid cited above.
- 15. All the appointing authorities are instructed to complete the pre appointment formalities promptly on or before 17.10.2025 (Friday) looking to the upcoming "Rojgar Mela" to be held on 24.10.2025 (Friday) and submit joining report to this office by 31.10.2025(Friday).
- 16. A copy of this Memo should be pasted in the Service book of the candidates on their appointments.
- 17. The receipt of this memo should be acknowledged.
