9 Seti-2= 22/12/2015 The guidelines for reservation in promotion to Persons with Benchmark Disabilities (PwBDs) issued by DoPT OM No. 36012/1/2020-Estt. (Res.-II) dated 28.12.2023 and issued by SCT Section, DoP letter No. SC-12/9/2022-SCT-DOP dated 09.01.2024 is followed in letter and spirit.

The Proviso of Section 34 of the Right of Persons with Disabilities (RPWD) Act, 2016 provides that the reservation in promotion shall be in accordance with such instructions as are issued by the appropriate Government from time to time.

As per the Department of Personnel & Training (DoPT) Office Memorandum No. 36012/1/2020-Estt. (Res.-II) dated 17.05.2022, four percent (4%) of the total number of vacancies in the cadre strength within Group 'C', from Group 'C' to Group 'B' and from Group 'B' to the lowest rung of Group 'A' shall be reserved for PwBDs. Reservation in promotion shall be applicable in the cadres in which the element of direct recruitment, if any, does not exceed 75%.
