The Competent Authority is pleased to order the promotion of following LSG (PO) cadre officials to the HSG-II (PO) cadre on regular basis in the Level – 6 in Pay Matrix (Pre-Revised Pay Band -2, Rs. 9300-34800/- with Grade Pay Rs. 4200/-) w.e.f. 01.01.2026 or from the date of assumption of charge, whichever occurs later, based on recommendations of the DPC held on 19/22.12.2025 for the vacancy year 2026. The Competent Authority has further ordered division allotment to promoted HSG-II (PO) cadre officials noted against each. Details are as under:-

2. These allotments have been ordered based on the recommendations of the "Transfer and Placement Committee" of the Circle Office duly approved by the Competent Authority.
3. The officials shall be promoted to HSG-II(PO) cadre w.e.f. 01.01.2026 or from the date assumption of charge, whichever is later, consequent upon the issue of posting orders by the concerned divisions. The responsibility of timely relief of the official would be that of the controlling officer.
4. The above promotions have been made on the basis of details of the officials eligible for promotion and special reports submitted by the Divisions. The Divisional Heads will go through these orders and examine the details of the official's w.r.t. their eligibility for promotion including their names in service records and if any discrepancy is found, it should be promptly reported to the Circle without issuing any further orders. It should be ensured the no Vigilance / Disciplinary case is pending against the officials, while effecting the promotion.
5. In case any vigilance / disciplinary case of the type referred to in OM No.22011/2/86-Estt (A) dated 12-01-1988 of DoP&T circulated vide Directorate memo. No.25-19/88-SPG dated 4-05-1988 and subsequently revised vide DoP&T memo. No. 22022/4/91-Estt (A) dated 14-09-1992 circulated vide Directorate memo no.25-19/88-SPG dated 13-10-1992 is pending against the officials, he / she should not to be relieved for posting without obtaining specific orders from this office.
6. It should also be ensured before ordering said promotions that SC/ST/PwBD certificates of the officials being promoted against SC/ST/PwBD vacancies are verified from the concerned sources and if any discrepancy is found, it should be promptly intimated to this office without issuing any further orders.
7. The Appointing Authority reserves the right either to modify or cancel the promotion, if later on any of the officials is found ineligible for the promotion from any angle. No separate notice will be issued whenever modification / revision / cancellation are ordered.
8. The Divisional Heads concerned will issue transfers / postings order within 05 days from the date of issue of this memo and also ensure the relieve of the officials to join or decline the new post within 15 days issue of posting order. If the officials do not join or decline within the stipulated time period, it will be deemed declination of the promotion.
9. The promotion of above said officials will take effect from the date of which the officials actually join the post of HSG-II (PO) after the issue of posting orders by the Divisions. Relief of the above said officials to the promotional post wherever necessary should be ordered by the Heads of Division/ Unit only after satisfying the above points.
10. The officials promoted on regular basis are not entitled for any pay fixation if they already have availed the benefit by virtue of financial up-gradation under TBOP/BCR/MACPS. They will continue to get their present stage in Pay Matrix/ Pay Band/Grade Pay without any further fixation on promotion to HSG-II(PO) Cadre ordered in this memo. The officials, who are entitled for fixation of pay, will have the option to have their pay, fixed under FR-22 (1) (a) (1). This option should be exercised within one month from the date of promotion. Option once exercised is final.
11. The declination, if any, will be disposed by the Appointing Authority concerned. In case any of the officials decline the promotion, no fresh offer of appointment on promotion shall be made for a period of one year from the date of refusal of promotion or till a next vacancy arises, whichever is later. On the eventual promotion to the higher grade, such Government servant will lose seniority vis-à-vis his juniors promoted to higher grade earlier. The Divisional Heads should send a consolidated report to Circle Office in time about the declination of the officials along with application of officials.



12. If any of the promoted officials refuses to accept the regular promotion before becoming entitled to a financial up-gradation, no financial up-gradation under MACPS shall be allowed as such he has not been stagnated due to lack of opportunities. If, however, financial up-gradation has been allowed due to stagnation and he subsequently refuses the promotion, it shall not be a ground to withdraw the financial up-gradation. He shall not be eligible for further financial up-gradation under MACPS, till he agrees to be considered for promotion again and the second and the next financial up-gradation shall also be deferred to the extent of period of debarment due to the refusal.

13. The divisional allotment is subject to change if there is any variation in the vacancies in any division.

14. If any official refuses the promotion, the concerned Divisional Head will send the refusal to Circle Office by 10.01.2025. Refusal received after this date will not be entertained.

15. Requests for re-allotment to any other division shall not be entertained under any circumstances. Therefore, Division should refrain themselves from making such recommendations.
