The MTS result has been compiled taking the scores of Paper-I for Circle Merit as per (i) the Department of Posts Multi-Tasking Staff Recruitment Rules, 2018 vide Gazette Notification dated 16.08.2018, (ii) Department of Posts Multi-Tasking Staff Recruitment (Amendment) Rules vide Gazette Notification dated 15.11.2019 & 30.08.2023, (iii) Directorate letter No. 37-33/2009-SPN-I (Pt) dated 29.09.2023 relating to unification of Multi-Tasking Staff (MTS) cadre in Department of Posts, (iv) Directorate letter No. 17-47/2024-GDS dated 14.10.2024 relating to guidelines to deal with the appointment of GDS to the Departmental Posts in the event of pendency of Disciplinary / Criminal Proceedings, Put off duty and currency of punishment on GDS, and (v) Postal Directorate letter No. 17-08/2018-SPN-I dated 18.10.2023 (Procedure for selection of candidate based on single examination for posts of Postman/Mail Guard and MTS).
- 5. Further, the orders/guidelines relating to Reservation in promotion to Persons with Benchmark Disabilities vide DoPT OM No. 36012/1/2020-Estt. (Res.-II) dated 17.05.2022 & Directorate letter No. X-20/17/2024-SPN-II dated 13.08.2024 along with DoPT OM No. 36035/02/2017-Estt (Res) dated 27.09.2022, and other extant rules/guidelines issued by Directorate from time to time, have been ensured. Accordingly, the own merit of the PwBD candidates has been considered and made applicable while preparing the merit list of GDS candidates for recruitment to the posts of MTS Cadre. - 8. The inter-se-seniority / merit of the GDS candidates with equal marks (Paper-I Merit) has been decided in accordance with the instructions / guidelines issued by Directorate vide Letter No. 04-08/2009-SPN-I dated 11.12.2020.
- 9. The Divisional/Unit Heads, before giving recruitment/appointment orders to the selected GDS candidates should ensure that the selected GDS candidates fulfill all required eligibility conditions of relevant Recruitment Rules of MTS cadre. Also, the Divisional/Unit Heads are advised to re-check all pre-requisite eligibility conditions prescribed for the GDS candidates, with reference to their recommendations made while forwarding the application forms.
- 10. Before appointment, it should be ensured that no disciplinary/vigilance case is pending or contemplated or punishment is in force against the successful/selected/allotted candidates. If, any such case exists, the same should be referred to this office immediately before issue of any further orders.
- 11. The information relating to name(s) of the candidate(s), Roll Number(s) and Category(ies) etc., have been shown on the basis of information furnished by the Regions/Divisions/Units. In case of any errors noticed in the details of candidate(s), the same may be intimated to this office for necessary action.
- 12. The candidates of reserved category i.e., SC/ST who are shown as qualified on merit and selected against UR vacancies should be adjusted against UR vacancies in the Roster.
- 13. In case, if it is found subsequently that any of the selected candidate(s) was/were not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case of any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates. Further, in case at any time, it is detected that the selected candidate had applied and appeared the examination with false information/declaration or data, his/her selection will be cancelled without any notice.
- 14. It may be ensured that no provisionally permitted candidate is given appointment without regularization of his/her candidature. The Divisions/Regions are directed to verify the current status of the candidature of the qualified candidates before issuing the offer of appointment to the Departmental post/cadre.

- 15. The Division/Unit Heads should ensure timely issue of offer of appointment letters to the successful GDS candidates so that the selected candidates join in their respective offices of posting at the earliest as per extant rules.
- 16. The successful candidates may be directed to accept and join in the place of posting on recruitment or to decline the appointment (Annexure III) <u>immediately</u>. The Divisional Heads are requested to issue recruitment/appointment orders to the successful GDS candidates, <u>immediately</u>. GDS on leave may be allowed to join even after leave period, if he/she communicate acceptance of the recruitment in writing and in that case the official will be allowed to join in the post after expiry of approved leave period. Controlling Officers are advised to contact such successful candidates who are on leave for obtaining their consent to join promotional post in writing. Similarly, candidates who do not wish to join the recruited post may be encouraged to communicate the same in writing.
- 17. The Divisions / Units may be directed to ensure completion of all the processes in this regard and report compliance to Circle Office by 31.12.2025. The guidelines issued vide Directorate letter No.W-04/2/2020-SPN-I-Part (1) dated 19.10.2020 and other extant guidelines issued from time to time in this regard may be taken into consideration while issuing appointment order.
