- 3. The selected candidates in the Annexure is subject to fulfillment of the conditions mentioned in Notification of the examination and relevant Recruitment Rules amended from time to time.
- 4. It is personal responsibility of the Appointing Authority to carry out verification of valid documents i.e., Date of Birth proof, Educational Qualification certificates, Category (ST/SC/OBC etc)/PWD certificate and other eligibility conditions for respective vacancy year, as per ruling on the subject before issuing provisional appointment orders to the selected candidates.

- 5. If it is detected at any time in future that the candidate so selected had applied-for and appeared-in the examination with false declaration relating to his/her educational qualification, category, length of service and physical disability etc., then his/her selection will be cancelled without any notice.
- 6. If it is noticed any time later that the permission granted to any candidate to appear for the examination was not valid due to one or the other reasons, as per the orders on the subject, the candidature will be cancelled without any notice and his/her name will be removed from the list of successful candidates at any stage.
- 7. The appointing authorities are requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time to time on the subject as applicable. Also, the Divisional/Unit Heads are requested to re-check the pre-requisite conditions prescribed for candidates, with reference to their recommendations while forwarding the applicant forms.
- 8. Before appointment, it should be ensured that, no disciplinary/vigilance case is pending or contemplated or punishment is current against the selected/allotted candidates. If it is found that any vigilance/disciplinary case is pending or contemplated against any of the candidate after the declaration of this result, then suitable action may be taken and such case should be reported to this office immediately through proper channel.
- 9. As per the instructions contained in Para2(c) and 2(j) of the Postal Directorate's Lr No. 17-08/2018-SPN-I dated 15/06/2022, the candidates selected should join as Multi-Tasking Staff within 7(Seven) days; and the candidates who are currently on leave at the time of declaration of result should submit their letter of acceptance of offer of appointment as Multi-Tasking Staff within the said 7(Seven) days' time even though they are on leave, failing which it will be assumed that the candidate concerned is not willing to accept the offer of appointment as Multi-Tasking Staff. Therefore, while issuing the offer/order of appointment, the appointing authorities concerned should invariably indicate in the offer-of-appointment that if the candidate fails to join as Multi-Tasking Staff/ join in the appointed post within 07(Seven) days, then it will be deemed to have been refused.


