1. As per Directorate guidelines issued vide Lr.No.141-141/2018-SPB-II dated 17.01.2019 "Temporary transfer shall be allowed to an official for a maximum period of 3 years in the entire service."
2. It may be noted that proposal for extension of temporary transfer should be sent to this office through proper channel at least 45 days before completion of approved period.
3. That the official will not claim TA or TP.
4. That the official will not claim any seniority / promotion by virtue of his/her service in the unit where he/she sought temporary transfer.
5. That he/she will revert to his/her parent unit at his own expenses, after the said period.
6. The lien of the official will be retained at his/her parent unit during the period he/she worked in the unit where he/she was given temporary transfer.

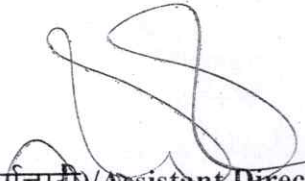

“This is a letter of purely provisional appointment and you do not have any claim towards regular appointment”.

The provisional appointment is subject to the following terms and conditions:

1. The appointment is purely temporary subject to the provisions of CCS (Temporary Services) Rules, 1965 as amended from time to time and will not confer any title for permanent appointment.
2. The candidates will be under probation for a period of two years. The clearance of probation period will be reviewed by Departmental Confirmation Committee after two years.
3. The conditions of the service will be governed by the relevant rules and orders in force from time to time.
4. The appointment may be terminated by a month's notice in writing either by appointing authority or by any other competent authority. The appointing authority however, reserves the right to terminating the services of the appointee forthwith or before the expiry of stipulated period of notice by making payments to him/her a sum equivalent to the pay and allowances for the period of notice or un-expired period thereof, if any, if the terms and conditions are not fulfilled.

5. The appointment carries with the liabilities to serve in any part of the Circle and in special circumstances, in any part of India. The appointee shall be liable for field service in time of war or national emergencies.
6. The appointment is not covered by the existing system of "defined benefit pension" and he/she will be governed by the New Pension Scheme introduced as per notification of the ministry of Finance, Department of Economic Affairs (ECB&PR Dn) resolution No. 5/7/2003-EDC & PR dated 10.10.2003 communicated vide No. 4-83/03-Pen dated 17.12.2003 of Ministry of Communications & IT, Department of Posts, India effective from 01.01.2004. In short, he/she is not governed by the existing CCS (Pension) Rules. But, 10% of Pay plus DA paid to him/her or the amount prescribed by Govt. of India from time to time will be recovered by the drawing officer as monthly contribution for pensionary benefits which will commence from the salary for the month following the month of appointment.
7. The appointment is provisional and subject to satisfactory completion of prescribed courses of training and the certificates being verified through proper channels. If the verification reveals that the claim of the candidate belonging to Scheduled Caste/Scheduled Tribe/other backward classes (not belong to creamy layer) is false or educational certificates are not genuine or found unfit on police verification, his/her services shall be terminated forthwith without assigning any further reasons and without prejudice to such action as may be taken under the provisions of Indian Penal Code for production of false certificate.

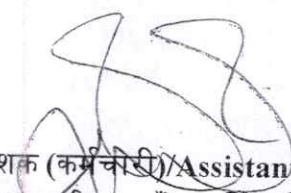

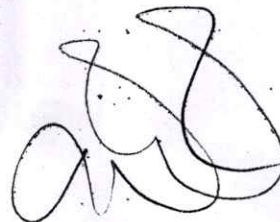
(ii) It is the responsibility of the officer to send a copy of the charge report on assumption of charge on promoted post of PS Group B cadre issued vide Directorate order dated 30.12.2025 to the Assistant Director (SPG-II), Postal Directorate, New Delhi- 110001 for information.

(iii) **officers should be relieved immediately to enable them to join on their promotional post. In case, posting order from the allotted circle is not received, the relieving Region shall relieve the promoted officer and ask the officer to report to the allotted Circle Headquarters. .**

(iv) In case of officer (s), who is not willing to accept his/her promotion, his/her declination letter in writing duly forwarded by the Regional office should reach this office within 30 days of issue of Directorate order. Non-assumption of charge within 30 days, without valid reason will be treated as deemed declination of promotion.

**5. VIGILANCE / DISCIPLINARY CASE, IF ANY:**

(a) If there is any vigilance/disciplinary case as referred to in DoP&T O.M. No. 22011/2/86-Estt.(A) dated 12.01.1988 issued by DoP&T circulated vide Directorate memo No. 25-19/88-SPG dated 04.05.1988 (subsequently) revised vide DoP&T memo No. 22022/4/91-Estt.(A) dated 14.09.1992 circulated vide Directorate Memo no. 25-19/88-SPG dated 13.10.1992 is pending against the official, **the official should not be relieved for posting without obtaining specific order from Directorate.** The promotion of the official should be withheld on mere ground that disciplinary action is contemplated, except the circumstances when the officer is under suspension or a charge sheet has been issued to the official or prosecution for a criminal charge is pending against the official. The official against whom any punishment is current except censure and recovery of money, they should not be promoted before expiry of currency



of punishment. **An intimation report in this report may be immediately to the Postal Directorate**

(b) The instructions issued by Personnel Division (SPN-II) section vide its letter No. SPN X-7/6/2022-SPN-II dated 12.04.2022 & 17.05.2023 will be ensured by the Regions.

punishment is current except censure and recovery of loss amount should not be promoted before expiry of currency of punishment. A report in this regard may be submitted immediately.

4. The above mentioned officials should accept/ decline the promotion unconditionally in writing within one month from the date of issue of this order. In case the official declines promotion, an unconditional declination letter may please be obtained immediately and to be forwarded to this office for its acceptance.
