

**Sub: Declaration of result of the Limited Departmental Competitive Examination/CE for promotion/recruitment to the posts of Postal Assistant/Sorting Assistant from eligible LGOs (Postman/Mail Guard/MTS) and GDS candidates for the vacancy year 2025 held on 17.08.2025 (Sunday) followed by Data Entry Skill Test (DEST) held on 18.09.2025. after clearance of Provisional Candidature.**


In continuation of this office Memo ADR(Con)/M-75/LGO & GDS to PA/SA/Exam/2025 No. dated 26.09.2025, the order of Competent Authority is hereby conveyed for declaration of results in respect of successful candidates of Limited Departmental Competitive Examination (LDCE)/Competitive Examination (CE) for promotion/recruitment to the posts of Postal Assistant/Sorting Assistant from eligible LGOs (Postman/Mail Guard/MTS) and GDS candidates for the vacancy year 2025 held on 17.08.2025 (Sunday) followed by Data Entry Skill Test (DEST) held on 18.09.2025, whose provisional candidature has been cleared.

2. The result of such successful candidates is enclosed at Annexure-1.
3. The information relating to the Name of the candidate, his/her Roll number and Community has been shown on the basis of information furnished by the Heads of Regional/Divisional office. The Head of the Division/Unit is requested that particulars of successful candidate, viz. Roll number, name, community and eligibility to appear in the said examination, are re-checked before declaration of result. They will also check that number of such candidate allotted to Division is not more than the number of vacancies proposed to be filled through the said examination.
4. In case, if it is found subsequently that the selected candidate was not eligible to appear in the examination under the existing Rules/Instructions on the subject or for any reasons or in case any discrepancy is found with regard to announcement of Result of the candidate for any reason whatsoever his/her name will be deleted from the list of successful candidate, as the case may be.
5. **The Division/Unit is requested to verify the Current Status of the candidature of the qualified candidate before declaration of the result.** If any discrepancy is found in respect of any item, the matter should immediately be reported to this office and respective result should not be declared until receipt of clearance from this office. **Further, in case of any disciplinary/criminal/ vigilance case is pending or punishment is current against any candidate, the matter should be referred to this office for obtaining the instructions and result should not be declared until receipt of clearance from this Office.**
6. This result is also subject to any change in merit list of selected candidates for any reason in accordance with the existing Rules and Instructions on the subject. It may be **ensured that no Provisional candidate is given appointment without regularization of the candidature** and such cases need not to be kept pending except in very exceptional & unavoidable circumstances.



7. Requests for re-totaling/revaluation will not be entertained in the light of instructions of the Directorate. Photo copies of Answer Sheets will be supplied to the candidates, on submission of application under RTI Act, only on furnishing OMR Form No. and Roll Number.
