Now, the Competent Authority is pleased to declare the **Supplementary Results (V) to fill up aforesaid unfilled vacancies of Postman Cadre that have arisen due to declination** from available qualified MTS candidates in accordance with the instruction contained in Directorate letter No.17-08/2018-SPN-I dated 18.10.2023 & 31.10.2023. The result has been compiled taking scores of both Paper I and Paper-II (combined i.e total marks secured in Paper I & Paper-II) as merit and Paper-III & Paper-IV (DEST) are qualifying in nature for the purpose of selection.

5. The results containing list of the next successful candidate of LDCE for promotion to the cadre of Postman/Mail Guard as per Circle Merit (combined Paper I+ Paper II) for vacancy year 2025 (01.01.2025 to 31.12.2025) in respect of LDCE held on 31.08.2025 followed by DEST held on 23.11.2025 arranged in the Circle merit order in respect of the declined vacancies is shown in **Annexure I**. The selection of these candidate(s) is purely provisional and subject to fulfillment of conditions of relevant recruitment rules for promotion to the cadre of Postman and Mail Guard. The result is also available in the Departmental websites (www.indiapost.gov.in & <https://karnatakapost.gov.in>). Candidates who have come in Merit in respective category, but could not be considered for Division/unit allotment due to limited options/ order of preference exercised by the candidates since the vacancies have already been allotted to more meritorious candidates above them on his/her turn of allotment are also indicated in the Results.

6. Candidates in this merit list who have been allotted Division / Unit and who have joined their allotted division will not be eligible for re-allotment to Divisions / Units (preferred by them) where vacancies may arise due to declination and these declined vacancies will be allotted to the next meritorious candidates below them in the list, even though these candidates rank junior to them in ranking.

7. In case, at any time, it is detected that the candidate(s) so selected had applied and appeared in examination with false declaration or data, his/her selection will be cancelled without any notice by the appointing authority or any other competent authority. For such an order this will be the notice issued in advance. No separate notice will be issued whenever modification/revision/deletion/cancellations are ordered. This should be incorporated in the promotion/appointment letters being issued.

8. All the vacancies notified in respect of Part(i) 50 per cent by promotion of MTS of the recruiting postal circle on the basis of LDCE for the vacancy year 2025 is filled up except the following vacancies:

(a) **12 (Twelve) UR vacancies** earmarked in respect of PwBD category i.e 5 VH, 1 HH, 2 OH & 4 Others in respect of the following Divisions are not filled due to non availability of qualified PwBD candidates and these vacancies are transferred to be filled through Competitive Examination for appointment of GDS to PM/MG cadre for the vacancy year-2025 as per PwBD guidelines.

(b) **Due to non availability of qualified candidate, One(1) ST vacancy of BG West Dn is transferred to be filled through Competitive Examination for appointment of GDS to PM/MG cadre for the vacancy year-2025 as per Recruitment Rules.**

(c) **In respect of these unfilled vacancies / horizontal reservation, Regions / Divisions may take necessary action as per instructions issued by DoPT and provisions of prevailing Recruitment Rules of MTS.**

9. If any discrepancies come to notice, it may be reported to this office immediately.



Promotion orders may be issued immediately in case of these successful candidate(s) clearly indicating that if the candidate does not join the promotional post on or before 27-01-2026 it will be deemed to have been refused. Candidate(s) on leave may be allowed to join even after ten days if they communicate in writing to accept the promotion and in that case the official will be allowed to join after expiry of approved leave period. The Divisional/Units heads are also requested to ensure timely issuance of joining orders to all the successful candidates immediately and joining process must be completed at the earliest. A consolidated report should be submitted to this office by Regional Offices on **30-01-2026 through email by 16.00 hours.**

11. All other terms and conditions mentioned vide this office memo of even no dated 09-12-2025, 16-12-2025, 19-12-2025, 27-12-2025 & 29-12-2025 holds good.
