This is continuation of this office memo of even no dated 24-12-2025 & 30-12-2025 in respect of the Single Competitive Examination (CE) for appointment to the cadre of Postman and Mail Guard from eligible GDS of the Circle for the vacancy year 2025 (01.01.2025 to 31.12.2025) held on 31.08.2025 and Data Entry Skill Test (DEST – Paper IV) to qualified candidates in Paper I, II & Paper III held on 23.11.2025.

2. The Competent Authority has accepted the declination submitted by the following candidates for CE for appointment to the cadre of Postman and Mail Guard from amongst eligible GDS of the Circle for the vacancy year 2025 (01.01.2025 to 31.12.2025) issued vide memo of even no. dated 24-12-2025.

Now, the Competent Authority is pleased to declare the **Supplementary Results (II) to fill up aforesaid unfilled vacancies of Postman & Mail Guard Cadre that have arisen due to declination** from available qualified GDS candidates in accordance with the instruction contained in Directorate letter No.17-08/2018-SPN-I dated 18.10.2023 & 31.10.2023. The result has been compiled taking scores of both Paper I and Paper-II (combined i.e total marks secured in Paper I & Paper-II) as merit and Paper-III & Paper-IV (DEST) are qualifying in nature for the purpose of selection.

5. The results containing list of the next successful candidates of Competitive Examination held on 31.08.2025 followed by DEST held on 23.11.2025 for **provisional appointment** to the cadre of Postman/Mail Guard as per Circle Merit (combined Paper I+ Paper II) for vacancy year 2025 (01.01.2025 to 31.12.2025) arranged in the Circle merit order in respect of these declined vacancies is shown in **Annexure I(alongwith one carried forward "ST" vacancy)**. The selection of these candidate(s) is purely provisional and subject to fulfillment of conditions of relevant recruitment rules for appointment to the cadre of Postman and Mail Guard. The result is also available in the Departmental websites ([www.indiapost.gov.in](http://www.indiapost.gov.in) & <https://karnatakapost.gov.in>). Candidates who have come in Merit in respective category, but could not be considered for Division/unit allotment due to limited options/ order of preference exercised by the candidates since the vacancies have already been allotted to more meritorious candidates above them on his/her turn of allotment are also indicated in the Results.

6. Candidates in this merit list who have been allotted Division / Unit and who have joined their allotted division will not be eligible for re-allotment to Divisions / Units (preferred by them) where vacancies may arise due to declination and these declined vacancies will be allotted to the next meritorious candidates below them in the list, even though these candidates rank junior to them in ranking.

7. *In case, at any time, it is detected that the candidate(s) so selected had applied and appeared in examination with false declaration or data, his/her selection will be cancelled without any notice by the appointing authority or any other competent authority. For such an order this will be the notice issued in advance. No separate notice will be issued whenever modification/revision/deletion/cancellations are ordered* ". This should be incorporated in the provisional appointment letters being issued. The word "Appointment" only should be used, the word "Promotion" should not be used in the provisional appointment orders being issued to GDS candidates.

8. All the vacancies notified in respect of Part(ii) **50 percent by direct recruitment on the basis of Competitive Examination limited to GDS of the recruiting Postal Circle** for the vacancy year 2025 is filled up except the following:

(a) **Three (3) UR vacancies i,e 1 VH vacancy of 2025 (Udupi Divisions), 1(one) HH vacancy of 2025(Mangaluru Dn) and 1(one) Others vacancy of 2025 ( BG East)** earmarked in respect of PwBD category is not filled due to non availability of qualified PwBD candidates and these vacancies are transferred to next recruitment year as per PwBD guidelines.

(b) Similarly Horizontal reservation in respect of 2- OH 2024 [ i,e BG East (1), BG West(1), 2-VH 2024(1 BG West & 1 BG South ) are transferred to next recruitment year as per PwBD guidelines due to non availability of qualified PwBD candidates.

(c) **12 (Twelve) UR vacancies** in respect of PwBD category i,e 5 VH, 1 HH, 2 OH & 4 Others which were transferred from LDCE-2025, remains undfilled due to non availability of qualified candidates. The said vacancies are transferred to next recruitment year (i.e.LDCE-2026) as per PwBD guidelines.

(d) **In respect of these unfilled vacancies / horizontal reservation, Regions / Divisions may take necessary action as per instructions issued by DoPT and provisions of prevailing Recruitment Rules of PM/MG**

9. Any discrepancies noticed may be reported to this office immediately.

10. Appointment orders will be issued in case of above successful candidate(s) immediately. Candidate(s) on leave may be allowed to join even after seven days if they communicate in writing to accept the promotion and in that case the official will be allowed to join after expiry of approved leave period. The Divisional/Units heads are also requested to ensure timely issuance appointment orders to all the successful candidates and joining process must be completed immediately. A consolidated report should be submitted to this office by Regional Offices on **30-01-2026**.

11. All other terms and conditions mentioned vide this office memo of even no dated 24-12-2025 holds good.


