

Sub: Announcement of 1st supplementary result of Limited Departmental Competitive Examination (LDCE) for promotion of Postman/Mail Guard, MTS and Competitive Examination for appointment of GDS to the cadre of Postal Assistants / Sorting Assistants for the vacancy year – 2025 (01.01.2025 to 31.12.2025) held on 17.08.2025 and DEST held on 29.10.2025 – Gujarat Circle

In continuation of this office letter of even number dated 06.11.2025 (vide which the results of the above LDCE/CE for the vacancy year 2025 held on 17.08.2025 was declared), the competent authority is pleased to declare 1st supplementary result of Limited Departmental Competitive Examination (LDCE) from Postman/Mail Guard, MTS & Competitive Examination (CE) for appointment of GDS to the cadre of Postal Assistants/ Sorting Assistants for the vacancy year – 2025 (01.01.2025 to 31.12.2025) held on 17.08.2025 and DEST held on 29.10.2025 appended vide Annexure – I.

2. As per Directorate's instructions issued vide letter no: X-12/6/2021-SPN-II dated 31.12.2021, a single merit list at Circle Level in respect of successful candidates of Category-A, Category-B and GDS candidates in aforesaid LDCE / Competitive Examination is prepared and the selected candidates have been allotted to the Divisions / Units as per relevant Recruitment Rules & instructions on the subject and as per their merit in Paper-I vis a vis order of preference exercised by the candidates.
3. The candidates who earlier submitted limited preference and were not allotted Divisions / units are now considered for allocation of Divisions / Units became vacant due to unwillingness of the selected candidates in accordance with Directorate letter No. W-04/8/2022-SPN-I-DOP dated 29.10.2024


- Since the above vacancies notified under Departmental promotion quota, no reservation for OBC and EWS categories is applicable as per the extant rules / guidelines on the subject.

5. The selection of the candidates is purely provisional subject to the fulfilment of required conditions of relevant Recruitment Rules & the verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. In case any vigilance/ Disciplinary case is pending against any of the officials, he/she should not be relieved for posting without obtaining specific orders from this office and instructions contained in Directorate's letter no: X-7/6/2022-SPN-II dated 17.05.2023 and amendment dated 22.09.2023 may be adhered to.

6. The name of the candidates has been arranged in the order of merit. In case of deciding of inter-se rank / merit in case of more than one candidate scoring equal marks, instructions contained Directorate's letter no: 04-08/2019-SPN-I dated 11.12.2020 have been followed. The information relating to the names of the candidates, their roll number, community, date of birth, date of joining etc. have been shown on the basis of information furnished by the Regions/ Divisions/ Units. If any case regarding merit/ seniority is arise later, the matter may be referred to Staff Section, Circle office, Ahmedabad for arranging their position according to their inter-se seniority/ instructions on the subject.


7. **Instructions for joining process of candidates:**

- The Divisional / Unit heads should ensure immediately issuance of offer of Appointment letter to the successful candidates within 3 (Three) days i.e. by 05.02.2026 so that the selected candidates / officials may join in their respective offices of posting at the earliest as per extant rules.
- The successful candidates may be directed to accept and join the place(s) of posting on promotion or to decline the promotion within 07 (seven) days from the date of

receipt of offer of appointment order (on or before 12.02.2026) without fail. If a candidate does not give his acceptance or refusal to join the offered post within the stipulated time, their promotion will be deemed to be declined.

8. Divisional Head will retain one copy of unwillingness received from the candidates and send the original copy of unwillingness along with attestation to **concerned Regional office by 17.02.2026**. Regional offices are requested to submit all these unwillingness to Circle office, Ahmedabad **on or before 18.02.2026** in a single lot.
9. The Head of the Divisions/Units are instructed to re-check the particulars of Successful candidates, viz. Roll numbers, names, community and their eligibility to appear in the said examination before issuing offer of appointment. If any discrepancy has been found during such exercise, the matter should be reported to this office promptly.
10. In case, if it is found subsequently that any of the selected candidate(s) was not eligible for the examination under the existing Rules/Instructions on the subject or for any reasons or in case any discrepancy is found with regard to announcement of Result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be.
11. **In respect of SC/ST/PwBD candidates:** "Promotion of the candidates is provisional subject to verification of their caste/PH status. Head of the Division/Unit will take an undertaking from the official/s to this effect at the time of their relieving and ensure verification of caste/PH status within stipulated time period".
12. This result is also subject to any change in merit list of selected candidates for any reason in accordance with the existing Rules and instructions on the subject. It may be ensured that no Provisional candidate is given appointment without regularization of the candidature and such cases need not to be kept pending except in very exceptional & unavoidable circumstances.
13. The result is prepared as per the guidelines received from Directorate and in accordance with the merit and preference exercised by the candidates. Therefore, no representation for re-allotment will be considered.
14. Kind attention is invited to the Para – 4 of the Directorate letter No. W-04/8/2022-SPN-I dated: 26.10.2023 which states that *"After giving order of preference for cadre, candidate shall give order of preference of Division/Unit for which they intend to be considered. A candidate shall not be considered for a Division/Unit for which preference has not been submitted by him/her"*. This clause was also mentioned under para – 5 of the Notification of LGO/GDS to PA/SA for the year – 2025. Furthermore, it was clearly mentioned under Annexure – III of the Notification dated: 09.06.2025 for the said examination that **'Applicants are required to indicate the order of preference of all Divisions/Units.'** Considering the clear guidelines on the subject matter, the

candidates shown under Annexure – II are not considered for a Division/Unit for which limited preference submitted.

15. All the Head of Divisions/Units of the selected candidates should be instructed to take necessary action for joining of newly selected candidates as per extent provisions. The Divisional/ unit heads are requested not to send separate letter of carrying out joining process/ appointment letters to Circle office, Ahmedabad. **The joining process should be completed on or before 12.02.2026.** A consolidated report to be submitted to this office by Regional office **on or before 18.02.2026** in a single lot.
16. **Before issuance of the offer of promotion/appointment to the selected candidates, Divisional / Unit Heads are instructed to check whether any official had refused offer of promotion earlier. In such case offer of promotion is to be issued not before completion of one year from the date of refusal of earlier offer of promotion as per Directorate's letter no. W-17/10/2023-SPN-I-DOP dated 06.03.2023.**
17. Requests for re-totalling / re-evaluation will not be entertained in the light of Rules/Instructions issued by the Directorate time to time. Photocopies of Answer Sheets will be supplied to the candidates, on submission of application under RTI Act, only on furnishing OMR form No. and Roll Number.
 - Candidates, who wish to have the copies of Answer Sheets supplied, are required to pay a fee of Rs. 25/- per paper with answer-key plus Rs. 10/-towards fee for application under RTI Act in the post office accounts and submit their applications through the Division/Unit concerned along with the receipt for payment of fee in original.
 - The prescribed period of preservation in respect of OMR / Answer sheets is one year from the date of declaration of this result. Therefore, application received after one year from the date of declaration of result for supply of photocopies of OMR / answer sheet will not be entertained.




