

Minutes of the Meeting of Circle Relaxation Committee held for consideration of the cases under Compassionate Appointment for the Vacancy year 2023 in Maharashtra Circle

As per Directorate's letter No. 17-4/2017-SPB-I/C dated 5th April 2018, Circle Relaxation Committee (CRC) at Circle level for considering compassionate appointment cases was constituted vide Circle Office letter no ADR/CRC 2023 Committee/Nominations/ 2025 dated 04.09.2025 with following members:

The Circle Relaxation Committee members met on 04.12.2025 at Circle Office, Mumbai. The committee dealt with the CRC applications in an online manner as per Directorate letter no. 17-12/2022-SPG-II dated 20.01.2023 and 03.04.2023. All the cases where date of application is on or before 30.06.2024 and death occurred till 31st December 2023, retirement on medical grounds before 19.05.2015, the cases referred by previous CRC for consideration for next CRC due to paucity of vacancies for the year 2022 as well as 4 cases have been reconsidered as per CAT orders for the vacancy year 2023.

2. The previous CRC for the vacancy year 2022 was held on 07.05.2024 for consideration of 227 cases for 177 vacancies (PA/SA-40, PM/MG-60 & MTS-60). In the CRC for the vacancy year 2022, 227 cases were considered which were received till 31.01.2023 and death occurred till 31st December 2022. Details of 227 cases are as below:


