Sub: Declaration of supplementary result of Special drive rectt (PM/MG-2023), to fill up the vacancies remained unfilled after declaration of result dated 25.11.2025 in Postman/Mail Guard in Delhi Circle from remaining candidates in merit list and leftover surplus qualified and willing GDSs candidates of LDCE, 2023 of all Circles.

This is in continuation of this office letter no. of even no. dated 25.11.2025 vide which the result was declared in respect of surplus qualified and willing GDSs candidates of LDCE, 2023 of other Circles to fill up the vacant posts of cadre of Postman/Mailguard upto year 2023 in Delhi Circle.

2. The Postal Directorate vide letter dated 31.12.2025 has accorded approval for declaring a supplementary result from the remaining candidates available in combined merit list and also from the left over candidates of all respective Circles.
3. The details of the leftover candidates were called from all Circle & compiled with the data of remaining eligible candidates available in the combined merit list .
4. In accordance with the approval of Dte. as mentioned in para 2 and instructions /SOP issued vide Dte. letter No. W-03/1/2020-SPN-I dated 26.06.2024 (already circulated vide this office letter dated 01.07.2024), a supplementary result of 29 GDS candidates selected provisionally against the vacancies occurred due to refusal/unwillingness of earlier selected PM/MG candidates and the vacancies were remained unfilled after declaration of PM/MG-2023 result dated 25.11.2025, is enclosed as **Annexure-I**.
5. SOP/ a step by step procedure for joining of selected candidates already issued & circulated vide this office letter no. R&E/R-1/PM-MG-MTS/NIT/2018(Part-B) dated 01.11.2024, may be referred for joining process of the candidate.
6. The particulars of candidates i.e. Names, Roll numbers, Category & Percentage/marks of the candidates etc have been taken from the soft data provided by their respective Circles. The concerned Circles/HoU's in Delhi Circle are requested that particulars of selected candidates as mentioned in the **Annexure-I** and the pending disciplinary proceedings & punishment under currency against any of the selected candidates may be checked and if any discrepancy is found in the particulars of any selected candidates, the same may be reported immediately to this office and appointment of the respective candidates may be deferred until receipt of clearance from this office. Further, name of candidates (which are in short of some candidates) and

Date of Birth of the candidates have been written in the result as provided by their respective Circles. So, the full name and DOB of the candidates may be tallied and taken as per the 10th class mark sheet of the respective candidate.

7. The respective circles are requested to send the personal files having all relevant document and verification reports, of the selected candidates to the allotted Divisional/Units in Delhi Circle latest by **25.02.2026** positively.
8. The allotted Divisions/Units shall complete the pre-appointment formalities and issue the offer of appointment to the selected candidates at the earliest without any unnecessary delay and send a copy of the same to the parent Division also through email.
9. All other instructions/guidelines issued earlier vide this office letter of even no. dated 25.11.2025 remain applicable and should be referred.
10. If any selected candidate is now not willing to join in Delhi Circle, the parent Division/Unit may obtain and forward his/her unwillingness to the allotted Division through email at the earliest.
11. Further, in case of pending disciplinary proceedings against any of the selected candidates, he/she may not be relieved until his/her discipline/vigilance clearance is cleared.
12. There is no unfilled vacancy in Mailguard cadre for the year 2023, hence, no candidate has been selected for Mailguard cadre.
13. The competent authority reserves the rights for any change/modification/cancellation of result of any candidates on administrative ground.
14. This issues with approval of the CPMG, Delhi Circle, New Delhi.
