Sub: Declaration of supplementary result –II of Special drive rectt.(MTS 2022) to fill up the vacancies remained unfilled after declaration of result dated 29.05.2025 in MTS in Delhi Circle from leftover surplus qualified and willing GDSs candidates of LDCE, 2022 of all Circles.

This is in continuation of this office letter no. R&E/R-1/PM-MG-MTS/Spcl Drive/MTS/2022 dated 29.05.2025 & 16.10.2025 vide which the main result & supplementary result were declared in respect of surplus qualified and willing GDSs candidates of LDCE, 2022 of other Circles to fill up the vacant posts of cadre of MTS for the years 2009 to 2022 in Delhi Circle.

2. Only Rajasthan Circle, vide letters dated **24.11.2025** and **01.12.2025**, furnished details of left-over candidates.
3. In accordance with the approval of the Directorate vide letter dated **12.09.2025** and instructions /SOP issued vide Dte. letter No. W-03/1/2020-SPN-I dated 26.06.2024 (already circulated vide this office letter dated 01.07.2024), a supplementary result-II of leftover of 04 eligible GDS candidates selected provisionally against the vacancies occurred due to refusal/unwillingness of earlier selected MTS candidates, is enclosed as Annexure-I .
4. SOP/ a step by step procedure for joining of selected candidates already issued & circulated vide this office letter no. R&E/R-1/PM-MG-MTS/NIT/2018(Part-B) dated 01.11.2024, may be referred for joining process of the candidate.
5. The particulars of candidates i.e. Names, Roll numbers, Category & Percentage/marks of the candidates etc have been taken from the soft data provided by their respective Circle. The concerned Circle/HoU's in Delhi Circle are requested that particulars of selected candidates as mentioned in the **Annexure-I** and the pending disciplinary proceedings & punishment under currency against any of the selected candidates may be checked and if any discrepancy is found in the particulars of any selected candidates, the same may be reported immediately to this office and appointment of the respective candidates may be deferred until receipt of clearance from this office. Further, name of candidates (which are in short of some candidates) and Date of Birth of the candidates have been written in the result as provided by their respective Circles. So, the full name and DOB of the candidates may be tallied and taken as per the 10th class mark sheet of the respective candidate.

6. The respective circles are requested to send the personal files having all relevant document and verification reports, of the selected candidates to the allotted Divisional/Units in Delhi Circle latest by **25.02.2026** positively.
7. The allotted Divisions/Units shall complete the pre-appointment formalities and issue the offer of appointment to the selected candidates at the earliest without any unnecessary delay and send a copy of the same to the parent Division also through email.
8. All other instructions/guidelines issued earlier vide this office letter of even no. dated 29.11.2025 & 16.10.2025 remain applicable and should be referred.
9. If any selected candidate is now not willing to join in Delhi Circle, the parent Division/Unit may obtain and forward his/her unwillingness to the allotted Division through email at the earliest.
9. Further, in case of pending disciplinary proceedings against any of the selected candidates, he/she may not be relieved until his/her discipline/vigilance clearance is cleared.
10. The competent authority reserves the rights for any change/modification/cancellation of result of any candidates on administrative ground.
11. This issues with approval of the CPMG, Delhi Circle, New Delhi.
