2. Accordingly, the competent authority has been pleased to declare the supplementary result of above said examination and under mentioned candidate is declared successful for appointment as Sorting Assistant against above-mentioned unfilled UR vacancy.

In case subsequently it is found that the qualified/selected candidate was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other 'reasons or in case any mistake is found with 'regard to announcement of the result of candidate for any reason whatsoever his name will be deleted from the list as the case may be. The result is also subject to any change in merit list of the selected candidate due to any unforeseen reason in accordance with the extant rules on the subject. The present result is further 'subject to outcome of court/ CAT cases, correction of clerical mistakes, if any. The candidature/ selection of the selected candidate is liable to be cancelled, if later on it is found that the false information has been given by the candidate or candidate was not eligible due to any disciplinary/ criminal case against him or otherwise. The result has been prepared on the basis of information furnished by the candidate and further verified by the Divisional Head. The concerned Divisional/ Unit Head is requested to carry Out all required-pre-appointment formalities as per prevalent Rules and instructions issued from time to time. Before appointment, it should be ensured that no disciplinary/Criminal case is pending/ contemplated or no penalty is current against the selected/promoted candidate.




5. The selection of the candidate is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules and the verification of genuineness of various mandatory certificates of the candidate by the concerned Head of Unit. In case any vigilance/disciplinary case is pending against the official he should not be relieved for posting without obtaining specific orders from this office.

6. **Instructions for candidates who decline promotion** :- If candidate is unwilling to accept promotion he should submit his unwillingness to the head of parent Division/Unit on or before 05.03.2026, failing which it shall be termed as "deemed declined".

7. The concerned Division Head is instructed to take necessary action for joining of newly selected candidates as per extant provisions. The Divisional Head is requested not to send separate letter of carrying out joining process / appointment letter to Circle Office. The joining process should be completed on or before 09.03.2026 positively.
