BENGALURU

In pursuance of the Postmaster General, Berhampur Region, Memo No. EST/3-Misc/2025-26 (BAM) dated 26.12.2025, it is ordered to close down Purushottampur NBS BO i.a.w Purushottampur S.O. under Chatrapur H.O. and to relocate the said post office to Chhakeipalli Village as Chhakeipalli Branch Post Office i.a.w Polosara S.O. under Chatrapur H.O. under Berhampur Postal Division establishment by relocation scheme as a part of Provision of banking facility within 5 KMs of all villages by a bricks and Mortar Post Office with IPPB touch points with immediate effect.

It is further ordered that Purushottampur NBS B.O i/a/w Purushottampur S.O. will be closed down after the **closing hour of 19.03.2026** and simultaneously Chhakeipalli B.O. will be **opened on 20.03.2026** with the following establishment on redeployment basis:-

SI No.	Name of the Post	Remark
1	GDS BPM-cum- MD -01	The post of BPM, Purushottampur NBS B.O i.a.w Purushottampur S.O. under Berhampur North Sub Division will be redeployed as BPM, Chhakeipalli B.O. i.a.w Polosara S.O.

The TRCA to be drawn after redeployment in favor of the GDSs will be same as drawn at their previous post.

The BPM, Chhakeipalli BO will be the sole custodian of the cash, stamps and valuables of the BO from the date of the opening of the BO i.e. 19.03.2026.

The working hours of Chhakeipalli Branch Office will be as follows:

1. Working hours: From 09.30 Hrs to 13.30 Hrs
2. The office will remain closed on **Sundays and Central Government notified Gazette Holidays.**

The following Mail arrangements will be given effect from the date of opening of Chhakeipalli BO:

The cash and stamps of Purushottampur NBS BO i/a/w Purushottampur SO must be zero at the closing of 19.03.2026.

The GDSBPM, Chhakeipalli BO will start working of BO with opening balance as per Cash and stamps remittances received from Sub-Postmaster Polosara SO.


The ASPOs, Berhampur North Sub Division should collect the existing date/name stamp and other seals of Kodala Bus Stand BO on the very date of its closure and hand over the same to the stock branch of Divisional Office.

The Stock branch of my office will supply the date stamps and seals bearing EXPTL PO with number till the receipt of stamps, and seal and letter heads in the name of the BO from PSD, Aligarh.

The ASPOs (I/C), Berhampur North should ensure closure of Purushottampur NBS BO on 19.03.2026 and opening of Chhakeipalli BO on 20.03.2026 observing usual formalities and make the necessary entries in their concerned registers.


