This is in continuation of this office letter of even no. dated 19.12.2025 where-under the result of Competitive Examination (CE) for recruitment to the post of Multi Tasking Staff (MTS) from eligible Gramin Dak Sevaks (GDSs) for the vacancy year 2025 (01.01.2025 to 31.12.2025) held on 31.08.2025 in Jharkhand Circle was declared.

2. Now, the Competent Authority is pleased to declare the 1st supplementary result of the Competitive Examination, 2025 for appointment to the post of Multi Tasking Staff (MTS) from eligible Gramin Dak Sevaks (GDSs) for the vacancy year 2025 (01.01.2025 to 31.12.2025) enclosed as **Annexure I**.

3. Allotment of Division/Unit to the successful candidates will be declared on the later date.

4. As per the Mutli Tasking Staff Recruitment (Amendment) Rules 2023, notified in GSR 639(E) dated 30.08.2023, Postal Directorate's instructions in letter no. 17-08/2018-SPN-I dated 18.10.2023 & dated 31.10.2023, a single merit list at Circle Level with the successful candidates of the above Competitive Examination is prepared.

5. The selection of candidates in **Annexure-I** is purely provisional and subject to fulfilment of conditions of relevant recruitment rules for appointment to the cadre of MTS as per directorate instruction contained vide letter No. X-7/6-2022-SPN-II dated 17.05.2023, 22.09.2023, 04.03.2024 and No. 17- 47 / 2024-GDS dated 14.10.2024.

6. Every care has been taken while preparing the result, however, if any discrepancies come to notice, it may be reported to this office immediately before issuing the result to the successful candidates.

7. In respect of candidates of reserved categories, "promotion/appointment of the candidates is provisional subject to verification of their caste status. Head of the Unit will take an undertaking from the official to this effect at the time of their relieving and ensure verification of caste status within one month".

8. Division shall ensure vigilance status of the official in terms of instructions issued vide Postal directorate letter no. X-7/6/2022-SPN-II dated 17.05.2023 as amended from time to time, before relieving him/her for appointment to the MTS post. In case any official falls under any of the category which attracts provision of "deemed sealed cover", such officials should not be relieved and the matter be immediately reported to this office.

9. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the head of Divisions/Units. In case there are any mistakes in the details of candidates, the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidates was not eligible to take the examination under the existing rules/instructions on the subject or for any reason or in case any mistake is found with regards to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, the selection will be cancelled without any notice, as the case may be.

10. If any discrepancies/irregularities/omissions found in name, roll no., marks, community etc. at any stage, the result of the said candidate to be cancelled/modified without issuance of any notice.


