Sub: Declaration of result in r/o the Competitive Examination for direct recruitment to the cadre of MTS from eligible GDS for the vacancy year 2025, held on 21.09.2025.

Ref: Circle Office notification No. R&E/77-17/2025 dated 15.07.2025.

In pursuance of this office notification cited under reference, the competent authority has directed to declare the result of Competitive Examination (CE) for recruitment to the cadre of MTS from eligible GDS candidates for the vacancy year 2025 (01.01.2025 to 31.12.2025), held on 21.09.2025.

2. The list of successful GDS candidates selected for the post of MTS against the vacancies notified in notification referred above, is enclosed as Annexure-I. The summary of filled and unfilled vacancies is enclosed as Annexure-II.

3. The selection of candidates has been made as per instructions contained in Directorate letter No. 17-08/2018-SPN-I dated 18.10.2023 followed by letter dated 31.10.2023. The merit list has been prepared on the basis of marks secured in Paper - I only.

4. In case of bunching, inter se rank/merit has been decided as per guidelines contained in Directorate letter No. 04-08/2019-SPN-I dated 11.12.2020.

5(i). One vacancy identified for Persons with benchmark Disabilities under OH category remained unfilled due to non-availability of eligible PwBD candidate. Further course of action will be taken in accordance with relevant instructions contained in DoPT letter No. 36012/1/2020-Estt. (Res.-II) dated 17.05.2022.

5(ii). Further, against 05 backlog vacancies reserved for PwBD category, only 01 vacancy could be filled with the available category of candidates. Out of remaining 04 backlog vacancies, only 01 could be filled by exchanging them with other available category of PwBD and the remaining 03 backlog vacancies were filled by exchanging with UR category, as per instructions contained in DoPT letter No. 36012/1/2020-Estt.(Res.-II) dated 17.05.2022.

6. The information related to the name of candidates, their roll numbers and their category have been shown on the basis of information furnished by the Divisions/Units. In case there are any mistakes in the details of candidates, the same may be intimated to this office for necessary action. In case it is found subsequently that any of the promoted/ selected candidate was not eligible for the examination/selection under the existing rules/ instructions on the subject or for any other reasons or in case any mistake is found with regard to declaration of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be.

This result is also subject to change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject.

7. The result of all successful candidates is subject to fulfillment of eligibility criteria to be decided by the concerned Divisional/Unit Head and vigilance status of the candidates. The candidates against whom vigilance or disciplinary case is pending/ those undergoing punishment should not be promoted, and such cases should be referred back to this office as per directions of Directorate issued from time to time.

8. Final Answer Keys of above examination have already been uploaded in the Departmental website i.e. www.indiapost.gov.in on 10.10.2025.

9. All the Divisional Heads/Appointing Authorities are requested to cause the issuance of promotion/appointment orders immediately. The appointing authorities are also requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time to time.


10. Divisional/Unit Heads are requested to take immediate necessary action for joining of newly selected candidates as per extant provisions. The Divisional/Unit Heads are requested not to send separate letter of carrying out joining process/appointment letters to Circle Office. The joining process should be completed on or before 20.05.2026.

11. Divisional /Unit Heads concerned are directed to submit the unwillingness/refusal of the candidate by 20.05.2026 along with the joining status of candidates. If any Division/Unit especially where the candidate is presently working is failed to submit the refusal within stipulated time to Circle Office, they will be held responsible for that.

12. Request for revised allotment of any candidate will not be entertained.

All Divisional/Unit heads are requested to display the above result on their office notice boards.
