2. The Postmaster General, Hyderabad / Headquarters Region are requested to issue necessary Divisional allotment orders to the divisions **immediately** so as to enable the Divisional Heads to issue posting orders to the promoted officials. On receipt of the posting orders, the official may please be relieved to join in his/her promotional post in case there is no Vigilance/Disciplinary case pending against him/her. The responsibility would be that of the controlling officer.

3. In case any Vigilance/Disciplinary case of the type referred to in the OM No.22011/2/86-Estt.(A) dated 12.01.88 and circulated vide Directorate's Memo No.25/19/88-SPG dated 04.05.88, subsequently revised vide DOPT Memo No.22011/4/91-Estt (A) dated 14.09.92 circulated vide Directorate's Memo No. 25-19/88-SPG dated 13.10.92, is pending against the officials, he/she should not be relieved for posting, without obtaining specific orders from this office. The official against whom any punishment is current, should not be promoted before expiry of currency of the punishment and a report in this regard should be sent to this office immediately.

The promotion of the official should not be withheld on the mere ground that disciplinary action is contemplated except the circumstances when the official is under suspension or a charge sheet has been issued to the official or prosecution for a Criminal charge is pending against the official.

4. The official may exercise his/her option for pay fixation under the provisions of FR 22(I)(a) (1) within one month from the date of assuming the charge in the promoted post. If the official is drawing his/her pay in level-5, level-6 and level-7 of pay matrix of 7th CPC, he/she is not eligible for pay fixation under provision of FR 22(I)(a) (1).

5. If any official in the promotion list is transferred to other Circles/ retired/expired or promoted as AAO/ IP, the issue may be brought to the notice of Circle Office.

6. The appointing authority reserves the right to either modify or cancel the promotion at a later date, if the official is found not eligible for the promotion or for any other cause. For such an order, this will be the notice issued in advance. No separate notice will be issued whenever modification/revision/cancellation is ordered.

7. If the promoted official refuses to accept the regular promotion before becoming entitled to a financial upgradation, no financial upgradation under MACP shall be allowed as he/she has not been stagnated due to lack of opportunities. If, however, financial upgradation has been allowed due to stagnation and he/she subsequently refuses the promotion, it shall not be a ground to withdraw the financial upgradation. He/she shall, however not be eligible to be considered for further financial upgradation under MACP, till he/she agrees to be considered for promotion again and the second and the next financial upgradation shall also be deferred to the extent of period of debarment due to the refusal.

8. The official should accept/ decline the promotion unconditionally in writing within **one month from the date of issuance of the posting orders**. In case the officials decline promotion, an unconditional declination letter may be obtained and to be forwarded to this office immediately for its acceptance. If he/she declines the promotion, he/she should note that he/she is not eligible for promotion to the cadre of HSG-II cadre for a period of 1 (one) year either on regular or on *ad-hoc* basis from the date of declination or till a next vacancy arises, whichever is later.

9. Non assumption of charges after 30 days of issuing of posting orders without any valid reasons would attract appropriate action against official viz. deemed declination of promotion etc.

10. No representation for re-allotment will be entertained before joining in the promoted post allotted. Hence, representations received from the officials for re-allotment before joining in the promotional post need not be sent to this office.

11. Re-allotment request, after joining in the post allotted, shall be sent through proper channel and will be considered only on recommendations of the concerned Regional Head.

12. Regions may send copy of the posting orders and charge reports invariably to this office. The date of joining of official in promoted cadre may please be intimated.

13. Regions are requested to intimate whether the promoted officials have successfully completed two weeks Departmental Training related to the duties and responsibilities of the higher post as per the instructions contained vide Directorate Lr.No. 44-19/2009-SPB-II dated 01.01.2014 of Recruitment Rules, 2014 for the post of Higher Selection Grade-II in Post offices or otherwise. Further, it is instructed that if the above said officials have not undergone the training earlier, they shall undergo successful training within a period of one year from the date of acceptance of promotion.
