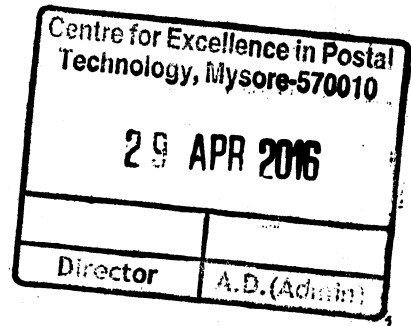
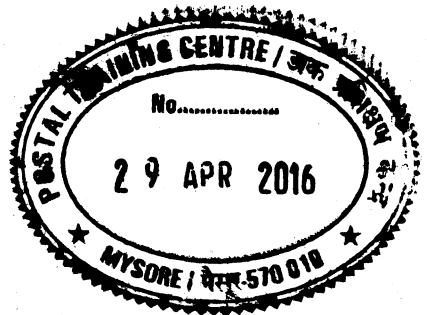

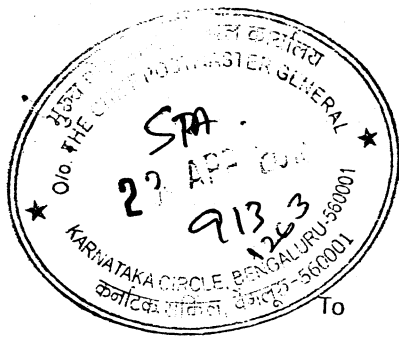

Sir/Madam,

The undersigned is directed to refer to DOP&T O.M. No. 407/12/2014-AVD-IV (B) dated 12th April, 2016 on the subject mentioned above vide which further instructions have been issued regarding furnishing of information relating to assets and liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013. The schedule for filing of returns has been revised as mentioned below:

- i. The first return of assets and liabilities as on 1st August, 2014 under the Lokpal and Lokayuktas Act, 2013 – on or before the 31st July, 2016
- ii. The next annual return of assets and liabilities as on 31st March, 2015 under the Lokpal and Lokayuktas Act, 2013- on or before the 31st July, 2016.
- iii. The annual return assets and liabilities as on 31st March, 2016 under the Lokpal and Lokayuktas Act, 2013 should be filed on or before 31st July, 2016.
- iv. The annual return for subsequent years on 31st March every year should be filed on or before 31st July, of that year.

All concerned under your jurisdiction may be suitably advised for strict compliance of the instructions issued by the DOP&T as specified herein above to file the declarations/returns within the given time-limit.
