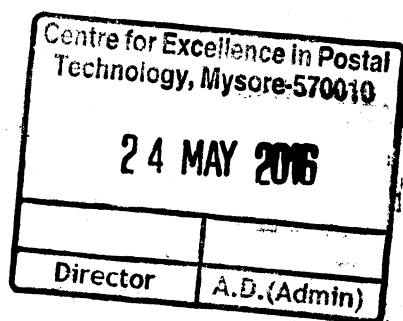
OFFICE MEMORANDUM
