- 5. The PMG Vadodara/ Rajkot will please issue posting order of the officer allotted to them and send report regarding assumption of charge and relief of officer.

GENERAL CONDITIONS:-

- (i) No re-allotment requests will be entertained within a period of one year. Leave taken for 15 days or more during this period will not be counted for calculation of one year period for considering requests for re-allotment. Even after completion of one year, the re allotment requests sent without proper channel will also not be entertained.
- (ii) Appointment is conditional to the officer's placement / joining in the designated circle / unit.
- (iii) It is the officer's responsibility to send a copy of the charge report on assumption of charge on the promoted post to Section officer (SPG), Postal Directorate, Dak Bhavan, New Delhi for record.
- (iv) Officer should be relieved within 15 days from the date of issue of this order. In case, the posting order from the allotted Circle is not received, the relieving circle shall relieve the promoted officer & ask the officer to report to the allotted Circle Headquarters.
- (v) In case, an officer is not willing to accept his promotion, his declination letter in writing duly forwarded by the circle office should reach to Directorate within 30 days from the date of issue of this order. Non assumption of charge after 30 days, without any valid reason, will attract appropriate action against the officer viz. Deemed declination of promotion.

5. VIGILANCE / DISCIPLINARY CASE, IF ANY:

In case any vig./disc. Case, of the type referred to in O.M. No.22011/2/86-Estt.(A) dated 12.01.88 from DOP&T circulated vide Dte's memo No.25-19/88-SPG dated 04.05.88 (subsequently) revised vide DOP&T memo No.22022/4/91-Estt.(A) dt. 14.09.92 circulated vide Dte memo No.25-19/88-SPG dated 13.10.92 is pending against the official, he should not be relieved for posting without obtaining specific orders from Dte. The promotion of the official should not be withheld on the mere ground that disciplinary action is contemplated, except the circumstances when the officer is under suspension or a charge sheet has been issued to the official or prosecution for a criminal charge is pending against the official. The official against whom any punishment is current, except Censure and recovery of money, he should not be promoted before expiry of currency of punishment. A report in this regard be submitted immediately.

6. **PROBATION PERIOD:**

The officer who has been promoted to the Postal Service Group 'B' will be on probation for two years and thereafter his suitability to hold the post will be adjudged on completion of two years of probation. If any official proceeds on leave for a period exceeding 30 days during this period, the probation period will be extended depending upon the period of leave.

7. TRAINING:

The officer will be directly promoted to Postal Service Group'B' without any training for the present. However they will have to undergo the prescribed training as and when notified by Director, Rafi Ahmed Kidwai National Postal Academy, Ghaziabad.

8. OPTION FOR FIXATION OF PAY:

If the officer who wishes to give option for choosing date for fixation of pay under FR-22(I)(a)(1) should do so within one month from the date of assumption of charge on promotion.
