I am directed to intimate that examination for promotion to the cadre of Inspector Posts for the year 2015-16 was held on 22nd & 23rd October, 2016 in 18 Circles. The said exam was not held in Assam, Bihar, Delhi, Haryana and Jammu & Kashmir. The Competent Authority has ordered for declaring the result of the above examination in respect of 18 Circles and accordingly, the result is hereby declared.

2. After holding the examination on 22nd & 23rd October, 2016, the Competent Authority ordered for displaying the provisional keys for all Papers in the Departmental website inviting comments/feedback from participants from 28.12.2016 to 06.01.2017. Accordingly, the feedbacks received from the participants were examined in detail.

3. After detailed examination of the issues, the Competent Authority ordered to revise the provisional keys in respect of following questions as detailed below:

8. **In case, subsequently if it is found that any of the selected candidate (s) was not eligible to take the examination under the extant rules or instructions on the subject for any other reasons or in case any mistake is found with regard to announcement of the result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be.**

9. **Provisional Candidates:** The Heads of the concerned Circles are requested to immediately finalize the candidature and such cases should not be kept pending for long time so that the provisional candidates may not have to wait for the result inordinately. It may also be ensured that no provisional candidate is given appointment under any circumstances without regularization of their candidature and approval of the Directorate. If name of any provisionally permitted candidate is found in the list of selected candidates, the same may be brought to the notice of Directorate for immediate necessary action.

10. It is informed that the names of the candidates have been arranged in the order of merit. In respect of candidates who got equal marks in the total, Circles are requested to arrange their position in the merit list according to their inter se seniority/instructions on the subject and intimate the same to DE/SPN Sections of the Directorate.


11. Applications under RTI Act for supply of photocopies of OMR Answer Sheets will be entertained in the following manner:

- (a) Candidates, who wish to have the copies of OMR Answer Sheets supplied, are required to credit a fee of Rs.25/- per Paper + Rs.10- towards fee for application under RTI Act in the Post Office accounts and submit their applications to the respective Circle Offices along with the receipt for payment of fee in original. Circle Office will supply copy of OMR Answer Sheet to the applicant. Scanned softcopies of OMR sheets will be supplied to the Circles soon.
- (b) A copy of this letter with enclosures has been uploaded on www.indiapost.gov.in. Requests for supply of this document under RTI Act will not be entertained.
- (c) The prescribed period of preservation in respect of OMR Answer Sheets is **one year** from the date of declaration of this result. Therefore, applications received after one year for supply of photocopies of OMR Answer Sheets will not be entertained.
- (d) Photocopies of OMR Answer Sheets will be supplied to only those candidates who have actually appeared in the Examination. Therefore, the candidates should invariably intimate their Roll Number in the Application made under the RTI Act.
- (e) **Request for supply of all India marks list under RTI Act will not be entertained as it will be uploaded in India Post website in public domain and can be accessed by individuals.** All the candidates may be informed accordingly.
- (f) The final key for the Question Papers I to IV will also be uploaded on www.indiapost.gov.in, Requests for supply of answer key under RTI Act will not be entertained.
- (g) The marks of the provisionally permitted candidates will not be displayed in the All India Master List and the marks of those candidates cannot be communicated until and unless their provisional candidature is regularized by the respective Circles. This may be made clear to all the concerned.

12 The Heads of Circles are requested for circulating this result to all the concerned and also to take necessary action for their Pre-Induction Training and other formalities before the selected candidates are appointed as Inspector Posts.






