Sub: Result of the Limited Departmental Competitive Examination for promotion to the cadre of Postal Service Group 'B' for the years 2012-13 to 2016-17, held on 18th December, 2016.

Sir/Madam,

I am directed to intimate that Limited Departmental Competitive Examination (LDCE) for promotion to the cadre of Postal Service Group 'B' for the years 2012-13 to 2016-17 was held on 18th December, 2016 at the 23 Circle Head Quarters. The Competent Authority has ordered for declaring the result of the above examination and accordingly, the result is hereby declared.

2. The names of selected candidates in IP line (19% quota) for the each year 2012-13, 2013-14, 2014-15, 2015-16 & 2016-17 are furnished in **Annexure A, B, C, D & E respectively**. Similarly, the names of selected candidates from General Line (6% quota) for the years 2012-13, 2013-14, 2014-15, 2015-16 & 2016-17 are furnished in **Annexure F, G, H, I & J respectively**.

3. The names of those candidates who were earlier declared as successful in LDCE PS Gr. B examination 2012 held on 3rd June 2012 as per supplementary result vide letter No. A-34013/03/2012-DE dated 26.02.2018, have been deleted from the merit/selection list of the examination held on 18.12.2016 and next meritorious candidates are selected. The supplementary result was declared due to revision in vacancy position by SPG Section of Postal Directorate in pursuance with the orders dated 10.10.2017 of the Hon'ble Supreme Court in SLP No. 24725/2017.

4. After holding the examination on 18th December, 2016, the Competent Authority ordered for displaying the provisional keys of both the papers (Paper-I & Paper-II) on the Departmental website inviting comments/feedback from participants from 06.02.2017 to 10.02.2017. Accordingly, the feedback received from the participants was examined in detail.

5. After detailed examination of the issues, the Competent Authority ordered to revise the provisional keys in respect of following questions due to being wrong with reference to the relevant rules/instructions. The details of questions are as under:

6. Also, the Competent Authority ordered to drop the following questions from evaluation due to being ambiguous, correct answers were not available or more than one correct answer was available resulting in lack of clarity.

7. The selection of the candidates is based on the following eligibility criteria:

UR Applicants	50% marks in paper-I i.e. 137/274 and 146/292 marks in paper-II and 50% in aggregate i.e. 283/566 marks.
SC/ST Applicants	40% marks in paper-I i.e. 109.6 (110)/274 and 116.8 (117)/292 marks in paper-II and 40% in aggregate i.e. 226.4 (227)/566 marks.

8. The selection has been made based on merit in the examination vis-à-vis earliest year of eligibility to appear in the examination. In those cases where two or more candidates get clubbed due to obtaining of equal marks against last vacancy of the particular year, the length of the service in the feeder post has been taken into account for this purpose.

9. The SPG Section of the Department of Posts vide letter No. 9-03/2018-SPG dated 21.03.2018 has recalculated the vacancies for the LDCE for promotion to PS Group 'B' cadre held in the year 2012 and onwards in pursuance of orders dated 10.10.2017 of the Hon'ble Supreme Court of India in SLP No. 24725/2017 and thus, vacancy position for the years 2012-13 to 2016-17 was revised by the SPG Section. The revised vacancy position pertaining to each year from the 2012-13 onwards is as under:

10. Thus, the result against total vacancies under Limited Departmental Competitive Examination for promotion to the cadre of Postal Service Group 'B' for the year 2012-13 to 2016-17 is declared except of those admitted to the examination on provisional basis.

11. In compliance with the directions of different Hon'ble Courts/CATs of different Benches, the result of concerned contesting candidates has been kept in sealed-cover. Also, the result of those candidates, who had been allowed to appear in the afore-said examination on provisional basis based on courts orders, has also been kept in sealed cover.

12. **Provisional Candidates:** The Heads of the concerned Circles are requested to immediately finalize the candidature and such cases should not be kept pending for long time so that the provisional candidates may not have to wait for the result inordinately. If name of any provisionally permitted candidate is found in the list of selected candidates, the same may be brought to the notice of Directorate for immediate necessary action.

13. It is informed that the names of the candidates have been arranged in the order of merit. In respect of candidates who got equal marks in the total, SPG Section of the Department of Posts is requested to arrange their position in the merit list according to their inter se seniority/instructions on the subject. It may also be ensured that no provisional candidate, if found in the list of selected candidates, is given promotion/appointment under any circumstances without regularization of his/her candidature.

14. The candidates, who had omitted to mention the series of Booklet on their OMR sheets or had mentioned two Booklet series on the OMR sheet, their OMR sheets were not machine-able and awarded marks to all of them as 'Zero'.
