**NOTIFICATION**

**Subject: Promotion and postings in Postal Service Group 'B' cadre.**

**No. 9-34/2011-SPG.** On the basis of supplementary result of Limited Departmental Competitive Examination held on 3<sup>rd</sup> June 2012 for the vacancy year 2012, declared by DE Branch of the Postal Directorate vide letter No. A-34013/03/2012-DE dated 26.02.2018 in pursuance of Hon'ble Supreme Court Order dated 10.10.2017 in SLP No. 24725/2017, the Director General Postal Services has approved the promotion of the following Inspector Posts line and General line official to Postal Service Group 'B' cadre on regular basis in the Level-9 (Rs.53,100 – Rs.1,67,800) of Pay Matrix (pre-revised Pay Band-2, Rs 9300-34800/- with Grade Pay Rs. 4800/-) with effect from the date of assumption of charge of the post and until further orders.

Satapathy and Shri Periasami S) are already working in PS Group 'B' cadre prior to declaration of the supplementary result vide ibid letter dated 26.02.2018 on promotion through DPC. Therefore, in their cases, no fresh allotment has been recommended.

5. The above allotment postings have been recommended by the duly constituted "Transfer and Placement Committee" in Directorate in accordance with instructions/ guidelines contained in this Directorate letter No. 9-23/2014-SPG dated 18.05.2018 and the recommendations are duly approved by the Competent Authority.



6. The Hon'ble Supreme Court of India vide its order dated 10.10.2017 in the above mentioned SLP has directed as following:

*"..it is clarified that promotion which has already been given may not be disturbed but **the respondents will be entitled to be considered against any future vacancies by making suitable adjustment in future in accordance with the impugned judgement.**"*

Accordingly, the officers promoted above will be get seniority of future vacancies which occurred during the year 2012-13 and onwards.

**7. GENERAL CONDITIONS:**

- (i) Re-allotment requests, if any, shall be entertained only after completion of tenure of three years in the Circle of posting on promotion. Leave taken for 15 days or more during this period will not be counted for calculation for considering requests for re-allotments. Even after completion of tenure, the re-allotment requests sent without proper channel will also not be entertained.
- (ii) Appointment is conditional to the officer's placement/joining in the designated Circle/ Unit.
- (iii) It is the officer's responsibility to send a copy of the charge report on assumption of charge on the promoted post to **Section Officer (SPG-II), Postal Directorate, New Delhi-1** for information.
- (iv) Officers should be relieved within 15 days from the date of issue of this order. In case, posting order from the allotted Circle is not received, the relieving Circle shall relieve the promoted officer and ask the officer to report to the allotted Circle Headquarters. Officers allotted to Postal Directorate will report to Assistant Director General (SGP), Dak Bhawan, New Delhi -1.
- (v) In case of officer, who is not willing to accept his/her promotion, his/her declination letter in writing duly forwarded by the Circle office should reach this Directorate within 30 days of issue of this order. Non-assumption of charge after 30 days, without any valid reason, will attract appropriate action against the officer, viz. deemed declination of promotion.

**8. VIGILANCE/DISCIPLINARY CASE, IF ANY:**

In case any vig./disc. case, of the type referred to in O.M. No. 22011/2/86-Estt. (A) dated 12.01.88 from DOP&T circulated vide this office memo No. 25-19/88-SPG dated 04.05.88 (subsequently) revised vide DOP&T memo No. 22022/4/91-Estt.(A) dated 14.09.92 circulated vide this office Memo no. 25-19/88-SPG dated 13.10.92 is pending against the officials, the official should not be relieved for posting without obtaining specific orders from this office. **The promotion of the official should not be withheld on the mere ground that disciplinary action is contemplated, except the circumstances when the officer is under suspension or a chargesheet has been issued to the official or prosecution for a criminal charge is pending against the official.** The official against whom any punishment is current except censure and recovery of money, they should not be promoted before expiry of currency of punishment. A report in this report may be submitted immediately.



**9. PROBATION PERIOD:**

The officials who have been promoted to the Postal Service Group 'B' will be on probation for two years and then their suitability to hold this post will be adjudged on completion of two years of probation. If any official proceeds on leave for a period exceeding 30 days during this period, the probation period will be extended depending upon the period of leave.

**10. TRAINING:**

The official will be directly promoted to Postal Service Group 'B' cadre without any training for the present. However, they will have to undergo the prescribed training as and when notified by Director, Rafi Ahmed Kidwai, National Postal Academy, Ghaziabad.


**11. OPTION FOR FIXATION OF PAY:**

If the officer who wishes to give option for choosing date for fixation of pay under FR-22[I](a)(1) should do so within one month from the date of assumption of charge on promotion.

**12. OFFICERS ALLOTTED OUT OF THEIR PARENT CIRCLES:**

The Circles will immediately issue posting orders and in any case not later than 22.06.2018. The CPMsG of the concerned Circle will report to Directorate regarding assumption of charge and relief of officers in their Circle in a consolidated manner by 09.07.2018 positively.


