ORDER

Sub: Promotion of Senior Time Scale (STS) officers of Indian Postal Service (IPoS), Group 'A' on ad-hoc basis to Junior Administrative Grade (JAG) of the service.

The President is pleased to order promotion of Senior Time Scale (STS) officers of Indian Postal Service, Group 'A', whose names appear in para 2 below, to Junior Administrative Grade (JAG) of the service in the Pay Matrix Level-12 (Rs. 78,800-2,09,200), purely on ad-hoc basis, initially for a period of one year with effect from the date of assumption of charge of the post, or until further orders, whichever is earlier.

2. On promotion on ad-hoc basis, the officers are posted against the posts as shown below:

3. The aforesaid ad-hoc promotion of the officers is subject to the following conditions:

- (i) The promotion on ad-hoc basis is effective from the date of assumption of charge of the post, where he/she has been posted as a JAG officer.
- (ii) The ad-hoc promotion shall be initially for a period of one year or until further orders, whichever is earlier. If orders for further continuation is not received before the expiry of one year period, the ad-hoc promotion shall automatically cease on the expiry of one year term.
- (iii) The ad-hoc promotions may be terminated at any point of time without giving any reasons thereof.
- (iv) The ad-hoc promotions shall not confer any right on the officers to continue in JAG indefinitely or for regular promotion to the grade.
- (v) The service rendered on ad-hoc basis in JAG would not count for the purpose of seniority in that grade or for promotion to the next higher grade.



- (vi) The ad-hoc promotions are further subject to vigilance clearance in terms of DoP&T O.M.No.22011/4/91-Estt.(A) dated 14.9.1992, O.M.No.22012/1/99-Estt.(D) dated 25.10.2004 and O.M.No.22034/4/2012-Estt(D) dated 2.11.2012 and also other relevant instructions. The office where the officers are posted on their ad-hoc promotion to JAG should issue their promotion orders only after verifying that no disciplinary proceedings are pending or contemplated against them. In case of pendency of such proceedings, the matter may be reported to this office immediately and the officer concerned should not be promoted on ad-hoc basis without obtaining specific orders from this office.
4. Col. Manohar Ram and Major Sunil Kumar [IPoS:2009] who are presently on deputation to APS will have to revert to their parent cadre i.e. Department of Posts for availing the actual promotion on ad-hoc basis.
5. The controlling officers/Head of Circles concerned shall ensure immediate relief of the above officers under local arrangements only after verifying their vigilance status as mentioned in Para 3(vi) above. They may be directed to report to their new places of posting immediately.
6. Relevant charge reports may be sent in due course.
