The Departmental Circle Relaxation Committee which met on 24.07.2018 and 25.07.2018 has considered a total number of 68 cases (including 3 Court Cases) for compassionate appointment received from the family members of the Deceased Departmental officials for appointment in Group-C Cadre.

The following is the vacancy position in different cadres in Group C which was arrived @ 5% of the total vacancies under DR Quota meant for Compassionate Appointment for the year 2017-18 as per the Directorate orders on the subject and the CRC has considered the cases for compassionate appointments and recommended the cases limited to the extent of vacancies are available.
