- 2.(a) The above allotment postings have been recommended by the duly constituted "Transfer and Placement Committee" in Directorate in accordance with instructions/ guidelines contained in this Directorate letter No. 9-23/2014-SPG dated 18.05.2018 and the recommendations are duly approved by the Competent Authority.
- 2.(b) Results of the LDCE in respect of Shri Hemant Kumar (of Delhi Circle) are kept in "Sealed Cover" in accordance with Para 7, read with Para 2 and 3.1, of the DoP&T OM No. 22011/4/91-Estt.(A) dated 14.09.1992.
- 2.(c) Promotion & postings orders in respect of Shri Purshotam Kumar (of Himachal Pradesh, appeared while working in APS Dte) will be considered on receipt of the vigilance status from the Circle concerned.
- 2.(d) Shri M. Sambasivudu (D.o.B.: 03.09.1957) belonging to Telangana Circle has already been retired from service on superannuation even prior to declaration of result (i.e. on 10.04.2018).
- 3. Inter-se-seniority of the selected officers will be fixed later on.
- 4. The vacancies were re-assessed/ recalculated for the above mentioned LDCE for the vacancy year 2015-16 and other vacancy years in pursuance of the judgment dated 10.10.2017 of the Hon'ble Supreme Court of India in SLP No. 24725/2017 (arising out of order dated 10.03.2015 of the Hon'ble CAT, Hyderabad Bench in OA No. 554/2013). The Hon'ble Apex Court has directed as following:
- "..it is clarified that promotion which has already been given may not be disturbed but the respondents will be entitled to be considered against any future vacancies by making suitable adjustment in future in accordance with the impugned judgement."

Accordingly, the officers promoted above will be get seniority of future vacancies which occurred during the year 2015-16 and onwards.

5. The above promotion will subject to final outcome of court cases as mentioned in the result of the LDCE issued vide Directorate vide letter No. A-34013/03/2012-DE dated 10.04.2018 and 26.04.2018.

- 6. The above promotion will also be subject to:
 - (a) directions passed by Hon'ble CAT, Bangalore Bench vide Orders dated 21.08.2018 in OAs No. 467/2018, 575/2018 and No. 761/2018.
 - (b) outcome in OA No. 387/2018 filed before the Hon'ble CAT, Ernakulam Bench
 - (c) outcome in OA No. 507/2018 filed before the Hon'ble CAT, Chandigarh Bench
 - (d) outcome in OA No. 249/2018 filed before the Hon'ble CAT, Jaipur Bench.
- 7. In accordance with DoP&T OM No. 36012/11/2016-Estt.(Res-I) {Pt-III} dated 15.06.2018 on the subject "Implementation of interim orders/ directions in Special Leave to Appeal (C) No. 30621/2011 arising out of final judgment and order dated 15.07.2011 in CWP No. 13218/2009 passed by the Hon'ble High Court of Punjab & Haryana and Special Leave to Appeal (C) 31288/2017 arising out of Hon'ble Delhi High Court judgment dated 23.08.2017 and other related court cases regarding", the promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court.

8. GENERAL CONDITIONS:

- (i) Re-allotment requests, if any, shall <u>not</u> be entertained before completion of tenure as envisaged in this Directorate letter No. 9-23/2014-SPG dated 18.05.2018.
- (ii) Appointment is conditional to the officer's placement/joining in the designated Circle/ Unit.
- (iii) It is the officer's responsibility to send a copy of the charge report through Head of Circle/ Director, PTC concerned on assumption of charge on the promoted post to Section Officer (SPG-II), Postal Directorate, New Delhi-1 for information.
- (iv) Officers should be relieved within 15 days from the date of issue of this order. In case, posting order from the allotted Circle is not received, the relieving Circle shall relieve the promoted officer and ask the officer to report to the allotted Circle Headquarters. Officers allotted to Postal Directorate will report to Assistant Director General (SGP), Dak Bhawan, New Delhi -1.
- (v) In case of officer, who is not willing to accept his/her promotion, his/her declination letter in writing duly forwarded by the Circle office should reach this Directorate within 30 days of issue of this order. Non-assumption of charge after 30 days, without any valid reason, will attract appropriate action against the officer, viz. deemed declination of promotion.

VIGILANCE/DISCIPLINARY CASE, IF ANY:

In case any vig./disc. case, of the type referred to in O.M. No. 22011/2/86-Estt. (A) dated 12.01.88 from DOP&T circulated vide this office memo No. 25-19/88-SPG dated 04.05.88 (subsequently) revised vide DOP&T memo No. 22022/4/91-Estt.(A) dated 14.09.92 circulated vide this office Memo no. 25-19/88-SPG dated 13.10.92 is pending against the officials, the official should not be relieved for posting without obtaining specific orders from this office. The promotion of the official should not be withheld on the mere ground that disciplinary action is contemplated, except the circumstances when the officer is under suspension or a chargesheet has been issued to the official or prosecution for a criminal charge is pending against the official. The official against whom any punishment is current except censure and recovery of money, they should not be promoted before expiry of currency of punishment. An intimation report in this report may be submitted immediately.

10. PROBATION PERIOD:

The officials who have been promoted to the Postal Service Group 'B' will be on probation for two years and then their suitability to hold this post will be adjudged on completion of two years of probation. If any official proceeds on leave for a period exceeding 30 days during this period, the probation period will be extended depending upon the period of leave.

11. TRAINING:

The official will be directly promoted to Postal Service Group 'B' cadre without any training for the present. However, they will have to undergo the prescribed training as and when notified by Director, Rafi Ahmed Kidwai, National Postal Academy, Ghaziabad.

12. OPTION FOR FIXATION OF PAY:

If the officer who wishes to give option for choosing date for fixation of pay under FR-22[I](a)(1) should do so within one month from the date of assumption of charge on promotion.

13. OFFICERS ALLOTED OUT OF THEIR PARENT CIRCLES:

The Circles will immediately issue posting orders and in any case not later than 11.09.2018. The CPMsG of the concerned Circle will report to Directorate regarding assumption of charge and relief of officers in their Circle in a consolidated manner by 28.09.2018 positively.
