Subject: - DPC for promotion to the Postal Service Group 'B' cadre for the vacancy year 2018 and 2019.

Madam/ Sir,

In supersession of letter of even number dated 01.04.2019 regarding the above mentioned subject, I am directed to say that for ensuring timely convening of DPC for promotion to Postal Service Group 'B' cadre for the year 2018 and 2019, the Competent Authority has directed that all the Circles may take urgent action as detailed below:

i. Action to complete the ACR/APAR dossiers (attested copy only) in respect of Inspector of Posts line officials (including ASPs) of OC/UR category upto the batch year 1995 and of SC/ST categories up to the batch year 2002, having at least 8 years' FINAL ACRs/ APARs up to year 2016-2017. (FINAL REPORTS means ACRs/ APARs duly communicated to the official, providing them an opportunity for representation within 15 days, and deciding the representation, if any, preferred by the official by issuing a speaking order. (Pl. refer to DoP&T OM No. 21011/1/2010 dt 13th April, 2010 and DoP&T OM No. 21011/1/2005-Estt (A) Pt-II dated 14.05.2009). The proposed list of such officers contains 244 names of IP line officials (Tentative eligibility list) as follows:

Upto Sl. No. 175 – IP line officials to be included in normal ZOC

From Sl. No. 176-244 – only SC/ ST category officials (to be included in extended ZOC)

ii. Accordingly, if any official's name has been left out in the list, the same may be immediately informed to this Directorate through email with full detail.

- iii. Any discrepancies, such as spelling of name, date of birth, category, etc may be checked by the Circle. If there is any discrepancy, the same may be informed separately at the time of submission of document. **No subsequent references will be entertained once the DPC is held. Circle will be solely responsible for not reporting such discrepancies, as all the relevant service particulars lies with Circle office only.**
- iv. If there is no report for any period, **'No Report Certificate'** with justified and acceptable reasons be prepared and placed in the dossiers appropriately.
- v. The Gradation Summary of all the ACRs/ APARs in respect of all the officials as per proforma enclosed at **Annexure-I separately. Annexure-I duly filled and signed may be placed at the front of APAR/ACR folder of each official.** This may be done in MS-Excel also in respect of all the officials, according to their seniority as per format **Annexure – II.** Annexure-II is to be submitted in soft as well as signed hard copies.
- vi. In respect of any official, information/ part of information pertains to other Circle, the same may be communicated to the Circle concerned directly under intimation to this office.
- vii. Latest vigilance status in respect of the officials along with statement indicating particulars of current punishment and penalties against officials, if any, be prepared in consolidated manner (seniority-wise) at Circle level for all the officials.
- viii. In compliance to DOP&T's OM No. 21011/1/2010 dt 13th April, 2010, a certificate (**Annexure-III**) to the effect that below benchmark ("Good" is the benchmark) grading has been communicated, with a copy of the relevant ACR, to the official and the concerned official was given 15 days time to make representation and on receipt of the representation, if any, the Competent Authority took a decision on it by issuing a speaking order.
- ix. Further, in pursuance of DOP&T OM No. 21011/1/2005-Estt (A) Pt-II dated 14.05.2009 regarding maintenance and preparation of APAR, a certificate may also be prepared in the enclosed proforma at **Annexure – IV.**
- x. There should not be any pendency on representations against the communicated adverse entries in ACRs/ APARs. The pending representations in respect of the officials belonging to the above batches, at least, be decided and disposed of with speaking order, prior to submitting the documents for DPC.
- xi. A statement of Penalties for the last ten years period in the enclosed proforma (**Annexure – V**) in respect of all the officials and also place a copy of the Penalty Order, if any, in the ACR/APAR folder of the concerned official.

xii. A separate list of officials, against whom any disciplinary proceeding is pending (in order of their seniority) as per proforma in Annexure-VI.

2. I am further directed to request that all the above information in prescribed formats i.e. Annexures – I to VI may be compiled and sent to Postal Directorate and the officer deputed for this purpose should not be below the rank of Assistant Director and he must well conversant with the matter. 
