OFFICE MEMORANDUM

Subject: Declaration of contents on Parcels by the sender.

Incidents have been reported by postal circles of COD items sent fraudulently with fake contents in parcels by some of the senders, specially smaller companies and groups selling products through internet or telephones (online), vis a vis the product ordered by the addressee. The circles have requested to prescribe mandatory declaration of contents of parcel/ shipment on the article at the time of booking at all locations and to provide for checking the contents inside parcels on random basis. The main reason put forth is to stop cheating by the sender in such cases and avoid disrepute attributed to the Department due to such incidents.

- 2. The matter has been examined taking into account the mandate of the Department, ruling position as well as the industry practices and it is observed that investigating the genuineness of the contents inside a parcel vis a vis the product ordered by the customer / addressee with the objective to detect any cheating by the e-commerce companies (senders) primarily does not fall in the domain of Department of Posts. There are genuine apprehensions across the e-commerce companies that declaration of actual contents on the parcel may increase the incidents of abstraction and theft of valuable contents, and therefore, should not be insisted upon.
- 3. Taking both the aspects into account and in light of Rule 43 of IPO Rules 1933 as mentioned above it has been decided with the approval of DG, Posts that:
- (i). Bulk Customers shall provide generic declaration of contents on the parcel/ shipment itself at an appropriately visible place; and further item wise declaration of actual contents has to be provided with the invoice or list / statement submitted to the booking office at the time of booking.
- (ii). Retail Customers shall provide declaration of generic or actual content on the parcel / shipment itself at an appropriately visible place or in a separate statement.

- 4. A proforma for information to be provided while booking a parcel 'Parcel Label' is prescribed as per Annexure-A. In case of Bulk Customers, providing data in soft /hard copy, to additional fields are added i.e. (a) actual contents, (b) value. The booking office shall maintain the relevant data along with booking data in physical / electronic form for a period as prescribed for these records.
- 5. It is also decided that the provisions on sending value payable articles dishonestly or fraudulently prescribed in Rule 109 (4) of Indian Post Office Rules 1933 will also apply to COD parcels mutatis mutandis (Copy attached as Annexure- B). This should be further read with Rule 221 and Rule 224 of IPO Rules 1933.

Note:- The conversion into Indian currency of the amount specified for remittance to the sender of a value – payable parcel posted in Iraq shall be effected at the rate of exchange for the issue of foreign sterling money orders in force on the date of receipt of the parcel in India.

(4) If a complaint is made by the addressee immediately after the receipt of the value payable postal article that it was sent dishonestly or fraudulently, the Postmaster General may, if satisfied, that there are prima facie grounds for believing that the value payable was sent dishonestly or with the intention of defrauding the addressee, with hold the payment of the sender of money recovered from the addressee. If after making such enquiries, as may be necessary, he is fully satisfied that the value payable postal article was sent dishonestly or with fraudulent intention, he may order the return of article to the sender and refund to the addressee the sum of money recovered from him on delivery of value payable postal article.
