It is the responsibility of the appointing authority to ensure genuineness of educational qualification of the candidate considered for compassionate engagement.

All the files listed in Annexure-I, II and III are returned herewith for taking further necessary action.

Speaking orders of rejected case mentioned in Annexure-II of Vijayawada Region are enclosed for arranging delivery under proper acquittance and copy of the acquittance may be sent to C.O. for record. Speaking orders pertaining to CAT cases of Kurnool Region may be prepared by the Region and arrange delivery under proper acquittance. 
