In case Period of punishment is reduced/ increased due to revision in punishment order, promotion order may be issued in respect of such officers by Circle/ Circles concerned on the expiry of revised period of punishment, under intimation to this Directorate.

5. GENERAL CONDITIONS:

(i) The Circles will immediately issue posting orders and in any case not later than 15.07.2019. The CPMsG of the concerned Circle will report to Directorate regarding assumption of charge and relief of officers in their Circle in a consolidated manner by 05.08.2019 positively.

- (ii) Appointment is conditional to the officer's placement/joining in the designated Circle/ Unit.
- (iii) It is the officer's responsibility to send a copy of the charge report on assumption of charge on the promoted post to <u>Section Officer (SPG)</u>, <u>Postal Directorate</u>, <u>New Delhi-1</u> for information.
- (iv) Officers should be relieved within 15 days from the date of issue of this order. In case, posting order from the allotted Circle is not received, the relieving Circle shall relieve the promoted officer and ask the officer to report to the allotted Circle Headquarters. Officers allotted to Postal Directorate will report to Assistant Director General (SPG), Room No. 236·F·1, Dak Bhawan, New Delhi ·1.
- (v) In case of officer, who is not willing to accept his/her promotion, his/her declination letter in writing duly forwarded by the Circle office should reach this Directorate within 30 days of issue of this order. Non-assumption of charge after 30 days, without any valid reason, will attract appropriate action against the officer, viz. deemed declination of promotion.

VIGILANCE/DISCIPLINARY CASE, IF ANY:

In case any vig./disc. case, of the type referred to in O.M. No. 22011/2/86·Estt. (A) dated 12.01.88 from DOP&T circulated vide this office memo No. 25-19/88·SPG dated 04.05.88 (subsequently) revised vide DOP&T memo No. 22022/4/91·Estt.(A) dated 14.09.92 circulated vide this office Memo no. 25-19/88·SPG dated 13.10.92 is pending against the officials, the official should not be relieved for posting without obtaining specific orders from this office. The promotion of the official should not be withheld on the mere ground that disciplinary action is contemplated, except the circumstances when the officer is under suspension or a chargesheet has been issued to the official or prosecution for a criminal charge is pending against the official. The official against whom any punishment is current except censure and recovery of money, they should not be promoted before expiry of currency of punishment. A report in this report may be submitted immediately.

7. VERIFICATION OF CASTE CERTIFICATE:

The caste/tribe certificate of the Officer belonging to SC/ST category who have been promoted to PS Group 'B' cadre may be verified and it may also be ensured that caste/tribe of the officers belonging to SC/ST category are still figuring in the notified central list of Schedule caste/tribe before actually giving them promotion. A certificate having undertaken such verification in respect of concerned officers may be intimated to this office latest by 05.08.2019.

8. PROBATION PERIOD:

The officials who have been promoted to the Postal Service Group 'B' will be on probation for two years and then their suitability to hold this post will be adjudged on

completion of two years of probation. If any official proceeds on leave for a period exceeding 30 days during this period, the probation period will be extended depending upon the period of leave.

9. TRAINING:

The official will be directly promoted to Postal Service Group 'B' cadre without any training for the present. However, they will have to undergo the prescribed training as and when notified by Director, Rafi Ahmed Kidwai, National Postal Academy, Ghaziabad.

10. OPTION FOR FIXATION OF PAY:

If the officer who wishes to give option for choosing date for fixation of pay under FR-22[I](a)(1) should do so within one month from the date of assumption of charge on promotion.
