**Subject: Limited Departmental Competitive Examination (LDCE) from Postman/Mail Guard & MTS & MTS(CO/RO) for the vacancy year 2019 and Competitive Examination for GDS for vacancy year 2015-16, 2016-17, 2017-18, 2018(01.04.2018 to 31.12.2018) and 2019 for recruitment to the cadre of Postal Assistant/ Sorting Assistant held on 15.9.2019 and DEST on 09.02.2020.**

With reference to the subject cited above, I am directed to declare the results of Limited Departmental Competitive Examination (LDCE) from Postman/Mail Guard & MTS cadre & MTS (CO/RO) to PA(CO/RO) for the vacancy year 2019 and Competitive Examination for GDS for vacancy year 2015-16, 2016-17, 2017-18, 2018(01.04.2018 to 31.12.2018) for recruitment to the cadre of Postal Assistant/ Sorting Assistant held on 15.9.2019. 
3. The following are the qualifying criteria for each paper for Competitive Exam from GDS to PA/SA cadre:-


9. The names of the candidates have been arranged in order of merit in the examination. The candidates are to be appointed in the allotted division after completing all pre-appointment formalities. The candidate of SC/ST/OBC/EWS should be verified before issue of appointment order if candidate has been allowed on the basis of reservation. Verification of educational certificate as per eligibility of GDS should also be ensured before appointment.

10. The names of candidates against the Roll. No. concerned has been shown as furnished by the Divisional/Unit heads. If, however, any mistakes in the Name/Roll No./Community of any candidates are noticed, the same may be corrected under intimation to this office.

11. The selected candidates should assume the charge at new place of posting within 30 days after issue of this letter. In case they do not want to go on promotion they will submit their refusal within 15 days from the issue of this letter. Concerned Divisional heads will issue their place of posting within a week from issue of this letter after observing all the formalities of appointment.


12. If any discrepancies/ irregularities /omissions found in name, roll no., marks, community etc. at any stage against any candidates, the results of the said candidates to be cancelled.
