Minutes of the 'Committee on Compassionate Engagement (CCE)' meeting held on 27-02-2020 to consider the cases of engagement in GDS cadre on compassionate ground

The 'Committee on Compassionate Engagement (CCE)' met on 27-02-2020 to consider the cases of engagement to GDS posts on compassionate ground. CCE is composed of the followings:-

1) Sri Amitabh Singh, PMG, Kolkata Region

- Chairman.

2) Sri Riju Ganguly, Director, PLI,

- Member.

3) Sri Ashoke Pal, DPS, South Bengal Region

-Member.

- 2. Total 47 cases were placed before the CCE for consideration out of which 42 cases have been recommended by the CCE for engagement in which 9 cases are belated (more than 1 year old) and 5 cases have been proposed to be rejected due to crossing the upper age limit and submission of educational certificate issued by a board which is not enlisted in the approved list of Ministry of Human Resource & Development.
- 3. The Committee on CCE obtained a certificate from ADPS (Rectt), CO stating that as on date there were no cases pending for compassionate appointment for placing before the Committee pertaining to any CAT/ Court order.

4. The Eligibility criteria for compassionate appointment in GDS cadre are as follows:

- (i) The applicant for compassionate engagement should be eligible and suitable for post in all respects as per the conditions prescribed for normal regular selection to the GDS post for which being considered.
- (ii) To the extent possible, compassionate engagement should be offered to a GDS post near the place where the family of the deceased GDS normally resides. However, if there are no suitable vacancies to engage the applicant to such post, any post in the same sub division or division may be offered.
- (iii) Request received after one year from the date of death of the GDS will be considered as belated requests. Such cases should be recommended by the CCE only, if the reasons given by the applicant are found to be genuine and convincing.
- (iv) In deserving cases even where there is already an earning member in the family, a dependent family member may be considered for compassionate engagement, if the CCE is satisfied that grant of compassionate engagement is justified having regard to number of dependents, assets and liabilities left by the GDS, income of the earning member as also his liabilities including the fact the earning member is residing with the family of the GDS and whether he/she should not be a source of support to their members of the family.

The Committee after examining all cases placed before them w.r.t. the relevant rules, records of the cases and instruction issued by the Directorate from time to time recommends following cases:
