
The CCE examined the above 37 fresh, 6 previous case in accordance with rules/instructions of the department laid down in Directorate letter no. – 17-1/2017-GDS dated 30.05.2017 and the letter no. 17-02/2018-GDS dated 08.03.2019 and 1 court case in accordance with the rule 17-17/2010-GDS dated 14.12.2010 & 09.03.2012.
