The Competitive Examination limited to GDSs is scheduled to be held on **Sunday, the 2<sup>nd</sup> August, 2020** for recruitment to the cadre of Multi-Tasking Staff (MTS) for the vacancy year 2018 (01-04-2018 to 31-12-2018) vacancy year 2019 (01-01-2019 to 31-12-2019) and for the vacancy year 2020 (01-01-2020 to 31-12-2020). \* Exam will commence exactly at 10.00 AM in all the Centres and both Paper-I and Paper-II will be conducted continuously from 10.00 hours to 12:10 hours. There will be 10 minutes break in between Paper-I and Paper-II, but candidates cannot be allowed to leave his/her desk.

The Regional Heads/Divisional Heads/controlling authorities are requested to start the activity as per the notified schedule immediately. The schedule should be strictly adhered to.

2. **Vacancy position:** The vacancy position for vacancy year 2018 and 2019 are enclosed in **Annexure-VI to IX**. The vacancy position for the vacancy year 2020 will be notified later.

**The vacancy may vary (i.e increase/decrease) due to Administrative reasons/Court Orders.**

**Note:** Even if there is no vacancy to be filled from GDSs in any Postal /RMS Divisions, examination will be held in that Division and all the eligible GDSs may be permitted to appear for the examination as they are eligible for allotment against the unfilled Multi-Tasking Staff (MTS) vacancies of the Circle against respective category subject to availability of vacancies in the quota.

3. **Eligibility Criteria :**

In accordance with the Directorate letter No. 02-01/2018-SPB-I dated 07-02-2019, MTS Recruitment Rules, 2018 is applicable for the vacancy year 2018, 2019 and 2020.

As per the provisions contained in Department of Posts, Multi-Tasking Staff (MTS) (Group C Post ) Recruitment Rules 2018 notified in GSR 781 (E) dated 16-08-2018 and Department of Posts, Multi-Tasking Staff (MTS) (Group C Post ) Recruitment (Amendment) Rules 2019 notified in GSR 850 (E) dated 15-11-2019 (**Annexure-II**), the **Gramin Dak Sevaks (GDSs)** who have worked regularly for three years in that capacity as on crucial date of eligibility are eligible to take up the above examination

5. **Age Limit** : There shall be no upper age limit for Gramin Dak Sevaks.

6. **Pattern and Syllabus**

The examination will be conducted as per the revised pattern and syllabus circulated vide by Directorate's letter No. 17-08/2018-SPB-I dated 10-05-2019 under **Annexure-A** read with Directorate letter 17-08/2018-SPB-I dated 26-06-2019, 28-06-2019, 11-07-2019 and 23-07-2019. ## 7. Examination Centre

The examination will be held at Bengaluru for Bengaluru HQ Region, venues to be decided by Postmaster General, North and South Karnataka Region. The candidates will have to appear from the respective centres of their Region only and under no circumstances they are permitted to appear from other regional centre. **The Regional PMsG will nominate the Supervising Officer for identifying the venue and communicating the same to all the concerned.**

## 8. Application Format: Application to be submitted in prescribed format (Annexure-I)

9. The application of the APS candidates should be sent to the concerned Divisions only and not to Circle Office. The APS Candidates have to appear for the examination from the Regional Centers, to which they belong.

## 10. ROLL NUMBER:

The Roll number shall comprise of six (6) Digits (NUMERALS). The first two digits shall denote the code number of the Division, followed by one digit for cadre code i.e "2" for GDS – Regular Candidature or i.e "4" for GDS – Provisional Candidature and next followed by three digits Roll Number starting from "001 to 999". - The GDS is not debarred from taking Examinations.

**सा.का.नि. 781(अ).**—राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और डाक विभाग (बहुकार्य कर्मचारिवृंद) भर्ती नियम, 2015, को उन बातों के सिवाय अधिकृत करते हुए जिन्हें ऐसे अधिक्रमण से पूर्व किया गया है, या करने का लोप किया गया है, डाक विभाग में बहुकार्य कर्मचारिवृंद के पद पर भर्ती की पद्धति के विनियमन हेतु निम्नलिखित नियम बनाते हैं, अर्थात् :-

1. संक्षिप्त नाम और प्रारंभ—

- इन नियमों का संक्षिप्त नाम डाक विभाग (बहुकार्य कर्मचारिवृंद) भर्ती नियम, 2018 है।
- ये राजपत्र में प्रकाशन की तारीख से प्रवृत्त होंगे।

2. पदों की संख्या, वर्गीकरण और वेतन मैट्रिक्स में स्तर— पदों की संख्या, उनका वर्गीकरण, और वेतन मैट्रिक्स में स्तर वे होंगे जो इन नियमों से उपाबद्ध अनुसूची के स्तम्भ (2) से (4) में विनिर्दिष्ट हैं।

3. भर्ती की पद्धति, आयु सीमा, अर्हताएं, आदि— भर्ती की पद्धति, आयु सीमा, अर्हताएं और उक्त पद से संबंधित अन्य बातें वे होंगी, जो उक्त अनुसूची के स्तम्भ (5) से स्तम्भ (13) में विनिर्दिष्ट हैं।

4. निरर्हताएं— वह व्यक्ति,—

- जिसने ऐसे व्यक्ति से, जिसका पति या जिसकी पत्नी जीवित है, विवाह किया है; या
- जिसने अपने पति या अपनी पत्नी के जीवित होते हुए किसी अन्य व्यक्ति से विवाह किया है,

उक्त पद पर नियुक्ति का पात्र नहीं होगा :

परन्तु यदि केन्द्रीय सरकार का यह समाधान हो जाता है कि ऐसा विवाह, ऐसे व्यक्ति और विवाह के अन्य फलकार को लागू स्वीय विधि के अधीन अनुज्ञेय है और ऐसा करने के लिए अन्य आधार हैं, तो वह किसी व्यक्ति को इस नियम के प्रवर्तन से छूट दे सकेगी।

5. सेवा डाक सेवा में सेवा करने की अपेक्षा.— उक्त अनुसूची में विनिर्दिष्ट पदों पर नियुक्त कोई व्यक्ति अपेक्षानुसार भारत में या भारत से बाहर सेवा डाक सेवा में सेवा करने का दायी होगा।

6. शिथिल करने की शक्ति.— जहां केन्द्रीय सरकार की यह राय है कि ऐसा करना आवश्यक या समीचीन है, वहां उसके लिए जो कारण हैं उन्हें लेखबद्ध करके, इन नियमों के किसी उपबंध को किसी वर्ग या प्रवर्ग के व्यक्तियों की बाबत, आदेश द्वारा शिथिल कर सकेगी।

7. व्यापृष्टि.— इन नियमों की कोई बात, ऐसे आरक्षणों और उन शिथिलताओं पर प्रभाव नहीं डालेगी, जिनका केन्द्रीय सरकार द्वारा इस संबंध में समय-समय पर जारी किए गए आदेशों के अनुसार अनुसूचित जातियों, अनुसूचित जनजातियों, भूतपूर्व-सैनिकों, अन्य पिछड़े वर्गों, और अन्य विशेष प्रवर्ग के व्यक्तियों के लिए उपबंध करना अपेक्षित है।

### NOTIFICATION

New Delhi, the 16th August, 2018

**G.S.R. 781(E).**—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Department of Posts (Multi Tasking Staff) Recruitment Rules, 2015, except as respect to things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Multi Tasking Staff in the Department of Posts, namely:—

- Short title and commencement.**— (1) These rules may be called the Department of Posts (Multi Tasking Staff) Recruitment Rules, 2018.

(2) They shall come into force on the date of their publication in the Official Gazette.
- Number of posts, classification and Level in the Pay Matrix.**— The number of posts, their classification and the Level in the Pay Matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- Method of recruitment, age limit, qualifications, etc.**—The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.
- Disqualification.**— No person,—

  - who has entered into or contracted a marriage with a person having a spouse living; or
  - who, having spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. **Requirement to serve in the Army Postal Service.**— Any person appointed to the posts specified in the said Schedule shall be liable to serve in the Army Postal Service in India or abroad, as required.
6. **Power to relax.**— Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
7. **Saving.**— Nothing in these rules shall affect reservations and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen, Other Backward Classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

**G.S.R. 850(E).**—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Department of Posts (Multi Tasking Staff) Recruitment Rules, 2018, namely:—

1. (1) These rules may be called the Department of Posts (Multi Tasking Staff) Recruitment (Amendment) Rules, 2019.
- (2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Department of Posts (Multi Tasking Staff) Recruitment Rules, 2018, in the Schedule,—
  - (A) in PART-I, under column (7), for the entries, the following entries shall be substituted, namely:—
    - “(i) 10<sup>th</sup> standard pass from a recognised Board;
    - (ii) knowledge of local language of the concerned Postal Circle or Division. The candidate should have studied local language at least up to 10<sup>th</sup> standard. The local language of a Postal Circle or Division shall be as published by the Department of Posts;
    - (iii) no educational qualification is prescribed for direct recruitment of Casual Labourer and Gramin Dak Sevak.”;
  - (B) in PART-II, under column (7), for the entries, the following entries shall be substituted, namely:—
    - “(i) 10<sup>th</sup> standard pass from a recognised Board;
    - (ii) knowledge of local language of the concerned Postal Circle or Division. The candidate should have studied local language at least up to 10<sup>th</sup> standard. The local language of a Postal Circle or Division shall be as published by the Department of Posts;
    - (iii) no educational qualification is prescribed for direct recruitment of Casual Labourer and Gramin Dak Sevak.”
